3 ACTING CHAIRMAN ALBERTI: Okay. The  
4 next case is Case No. 14-AUD-00082. This is a  
5 Show Cause (Status) Hearing regarding Sunnyside  
6 Group, LLC t/a Good Stuff Eatery, License No.  
7 78027.

8 Parties forward and introductions,  
9 please.

10 MR. RIVERO: Good morning, Board  
11 Members. Fernando Rivero for the District of  
12 Columbia standing in for Maureen Zaniel.

13 MS. WILKEY: Good morning, Board  
14 Members. My name is Karina Wilkey. I'm the  
15 controller of Good Stuff Eatery standing in for  
16 Mr. Harvey Mendelsohn.

17 ACTING CHAIRMAN ALBERTI: Okay.

18 MR. RIVERO: The licensee has a letter  
19 of representation.

20 MEMBER RODRIGUEZ: Oh, okay.

21 MS. WILKEY: Yes.

22 ACTING CHAIRMAN ALBERTI: Okay. And,

1 Ms. Wilkey, you have a letter of representation?

2 MS. WILKEY: I'm sorry.

3 ACTING CHAIRMAN ALBERTI: Okay.

4 Great. We will have someone get that from you.

5 Okay. So, Ms. Wilkey, this is a Show Cause

6 (Status) Hearing.

7 Did your client receive notice of Show

8 Cause?

9 MS. WILKEY: Yes, sir.

10 ACTING CHAIRMAN ALBERTI: Have they

11 read it and do they understand it?

12 MS. WILKEY: Yes, sir.

13 ACTING CHAIRMAN ALBERTI: Okay. So if

14 there is no objections, we will forego reading

15 this into the record, reading the notice into the

16 record.

17 Okay. Are there any preliminary

18 matters in this case?

19 MR. RIVERO: The parties have an Offer

20 in Compromise to present to the Board, at this

21 time. The term is a fine of \$2,000.

22 ACTING CHAIRMAN ALBERTI: Yes.

1 MR. RIVERO: Payable in 60 days with  
2 the understanding that if payment is not made in  
3 60 days, the license will be suspended until  
4 payment is received.

5 ACTING CHAIRMAN ALBERTI: Before I  
6 consider this, do you have any information on  
7 whether the outstanding report has been filed?

8 MR. RIVERO: I personally do not.

9 MS. WILKEY: Yes, sir, it was filed.  
10 It was filed late. I did not bring it in, but--

11 ACTING CHAIRMAN ALBERTI: But, Ms.  
12 Wilkey, it has been filed?

13 MS. WILKEY: Yes, sir.

14 ACTING CHAIRMAN ALBERTI: Okay.  
15 Great. So the Offer in Compromise, as I hear it,  
16 is a fine of \$2,000 to be paid within 60 days.  
17 If the fine isn't paid within 60 days, the  
18 license will be suspended until the fine --  
19 payment of the fine is made.

20 Ms. Wilkey, you have heard the Offer  
21 in Compromise.

22 MS. WILKEY: Yes.

1                   ACTING CHAIRMAN ALBERTI: Do you  
2 understand the Offer in Compromise and accept it  
3 on behalf of your client?

4                   MS. WILKEY: Yes, sir.

5                   ACTING CHAIRMAN ALBERTI: Okay. And  
6 do you understand that your client waives his  
7 right to a hearing based on this Offer in  
8 Compromise?

9                   MS. WILKEY: Yes, sir.

10                  ACTING CHAIRMAN ALBERTI: Great.  
11 Thank you.

12                  So Board Members, the Offer in  
13 Compromise is a fine of \$2,000 to be paid within  
14 60 days. And suspension of the license if it  
15 hasn't been paid within 60 days.

16                  Do I have a second?

17                  MEMBER SILVERSTEIN: Second.

18                  ACTING CHAIRMAN ALBERTI: Okay.

19                  All those in favor say aye.

20                  ALL: Aye.

21                  ACTING CHAIRMAN ALBERTI: All those  
22 opposed? The motion carries 6-0.

1                   And that concludes this matter.

2                   MS. WILKEY: Thank you.

3                   ACTING CHAIRMAN ALBERTI: Thank you  
4 for coming.
