3 CHAIRPERSON MILLER: Next is the Fuel
4 Pizza & Wings case. It's Case No. 14-CMP-00700.
5 Fuel Pizza & Wings is located at 1606 K Street,
6 N.W., License No. 88452, in ANC-2B. Okay. Would
7 you introduce yourself?

8 MR. RIVERO: Good morning, Board
9 Members. Fernando Rivero for the District of
10 Columbia standing in for Assistant Attorney
11 General Gephardt.

12 CHAIRPERSON MILLER: Okay.

13 MR. TABIEI: And I'm Omeed Tabiei.
14 I'm the representative for Fuel Pizza.

15 MR. RIVERO: A brief indulgence?
16 Okay. The parties have no Offer in Compromise to
17 present, at this time, and we are ready to move
18 to the next scheduled date.

19 CHAIRPERSON MILLER: Okay. Well,
20 first of all, I have to ask how are you the

13 CHAIRPERSON MILLER: Okay. All right.
14 So there is just no notice issue here. Okay.
15 Yes?

16 MR. RIVERO: One second please.

17 CHAIRPERSON MILLER: Yes.

18 MR. RIVERO: Okay. The representative
19 will file another form indicating that he is
20 representing the licensee for this case, since
21 the Agency's representation forms are case-
22 specific. And I realize now that the licensee

1 had filed a form for another case having to do
2 with another violation. So he will go ahead and
3 file a form that specifies this case.

4 CHAIRPERSON MILLER: Okay. All right.
5 You will do that?

6 MR. TABIEI: Indeed.

7 CHAIRPERSON MILLER: Okay. All right.
8 Good. Okay. Well, all that is happening, at
9 this point, I understand is that we are going to
10 be scheduling it for hearing. Is that correct?

11 MR. RIVERO: Yes.

12 CHAIRPERSON MILLER: Okay. Fine. All

14 Cause Hearing May 6, 2015 at 11:00 a.m.
