CHAIRPERSON MILLER: Okay. I'm going to call Case No. 12-CMP-00345, Eatonville, located at 2121 14th Street, N.W., License No. 78882 in ANC 1B.

MR. RIVERO: Good morning, Board Members. Fernando Rivero standing in for Assistant Attorney General Amy Schmidt for the District of Columbia.

MR. O'BRIEN: Stephen O'Brien for the Licensee. I'm accompanied by Any Shallal, S-H-A-L-L-A-L, who is the president of the corporate Licensee.

CHAIRPERSON MILLER: Okay. So this is a show cause hearing. Are there any preliminary matters?

MR. RIVERO: Yes. Actually we have an Offer in Compromise to present to the Board at this time.

CHAIRPERSON MILLER: Okay.

MR. RIVERO: And that Offer in

1 Compromise consists of a fine \$700 to be paid
2 today.

3 CHAIRPERSON MILLER: I'm sorry,
4 \$700?

5 MR. RIVERO: A fine of \$700 to be
6 paid immediately.

7 CHAIRPERSON MILLER: Okay.

8 MR. O'BRIEN: Madam Chair, to
9 refine that, I believe it's \$350 as to each of
10 the --

11 MR. RIVERO: That's correct. The
12 total is 700.

13 CHAIRPERSON MILLER: Okay. Right.
14 There are two charges, 350 each.

15 Okay. Let me just confirm with
16 the Licensee that he's agreeable to this fine
17 of \$700, which breaks down to \$350 for each of
18 two offenses. And it's to be paid
19 immediately, today.

20 MR. O'BRIEN: That's correct, and
21 we waive any right to a hearing.

22 CHAIRPERSON MILLER: Okay. Other

1 questions from Board Members?

2 (No audible response.)

3 CHAIRPERSON MILLER: All right.

4 Then I would move that we approve this Offer

5 in Compromise of a fine of \$700 to be paid

6 today. That breaks down to \$350 for each of

7 two offenses. Do I have a second?

8 MEMBER SILVERSTEIN: Second.

9 CHAIRPERSON MILLER: Mr.

10 Silverstein seconded the motion. Any comments

11 or questions?

12 (No audible response.)

13 CHAIRPERSON MILLER: All right

14 then. There's a motion to approve this Offer

15 in Compromise. All those in favor, say aye?

16 (Chorus of ayes.)

17 CHAIRPERSON MILLER: All those

18 opposed?

19 MEMBER ALBERTI: Opposed.

20 CHAIRPERSON MILLER: All those

21 abstaining?

22 (No audible response.)

1 CHAIRPERSON MILLER: So I believe
2 that the motion passes by a vote of 3-1-0.
3 Mr. Brooks, were you an aye?

4 MEMBER BROOKS: Aye. Yes.

5 CHAIRPERSON MILLER: Okay. Yes,
6 so that's 3-1-0.

7 And I'm just waiting to sign that
8 for you.

9 MR. O'BRIEN: Thank you.

10 CHAIRPERSON MILLER: Okay.

11 (Whereupon, the hearing was
12 concluded at 11:05 a.m.)
