3 CHAIRPERSON MILLER: The next case is
4 another Show Cause Hearing (Status). It's Case
5 No. 14-AUD-00077, We, the Pizza located at 305
6 Pennsylvania Avenue, S.E., License No. 82062, in
7 ANC-6B. Good morning.

8 MS. ZANIEL: Good morning.

9 MS. WILKEY: Good morning.

10 MS. ZANIEL: Maureen Zaniel on behalf
11 of the District of Columbia.

12 MS. WILKEY: Karina Wilkey
13 representing Kookoovaya d/b/a We, the Pizza.

14 CHAIRPERSON MILLER: Okay. And in
15 what capacity are you a representative?

16 MS. WILKEY: I am the comptroller of
17 the company. The owner is out of town and asked
18 me -- I have a letter asking that I represent
19 him, yes.

20 CHAIRPERSON MILLER: Okay. Perfect.
21 All right. Have you given that letter to any of
22 our staff?

1 MS. WILKEY: No, ma'am.

2 CHAIRPERSON MILLER: Okay.

3 MS. WILKEY: I have copies here, so I
4 can give you them.

5 CHAIRPERSON MILLER: Okay.

6 MS. WILKEY: Here you go. Would you
7 like a copy, ma'am?

8 MS. ZANIEL: Sure.

9 MS. WILKEY: Okay.

10 CHAIRPERSON MILLER: Okay. So I just
11 have to ask you, Ms. Wilkey, a preliminary
12 question. Did you all receive notice of this
13 hearing?

14 MS. WILKEY: Yes, ma'am, we did.

15 CHAIRPERSON MILLER: Okay. And did
16 you read the notice and understand it?

17 MS. WILKEY: Yes, ma'am.

18 CHAIRPERSON MILLER: Okay. So we
19 don't have any notice issues here related to this
20 hearing.

21 Okay. Are there any preliminary
22 matters?

1 MS. ZANIEL: Yes. There is a
2 recommended Offer in Compromise and that would
3 consist of a \$2,000 fine to be paid within 30
4 days. If not paid, the license would be
5 automatically suspended. And I would note that
6 the quarterly statement has been filed.

7 CHAIRPERSON MILLER: Oh, good. All
8 right. Perfect. Ms. Wilkey, are you agreeable
9 to an Offer in Compromise as represented to be a
10 \$2,000 penalty to be paid within 30 days, and if
11 it's not paid within 30 days, then the license
12 will be suspended until paid?

13 MS. WILKEY: Yes, ma'am.

14 CHAIRPERSON MILLER: Okay. You
15 understand that you waive your right to a
16 hearing?

17 MS. WILKEY: Yes, ma'am.

18 CHAIRPERSON MILLER: And you also
19 waive your right to appealing this penalty?

20 MS. WILKEY: Yes, ma'am.

21 CHAIRPERSON MILLER: Okay. Any
22 questions? All right.

1 Then I move that we approve this Offer
2 in Compromise of a \$2,000 penalty to be paid
3 within 30 days. If not paid within 30 days, the
4 license will be suspended until paid.

5 MEMBER SHORT: Second.

6 CHAIRPERSON MILLER: Mr. Short has
7 seconded the motion.

8 All those in favor say aye.

9 ALL: Aye.

10 CHAIRPERSON MILLER: All those
11 opposed? All those abstaining? The motion
12 passes 5-0-0.

13 Okay. Okay. Thank you very much.

14 MS. WILKEY: Thank you.

15 CHAIRPERSON MILLER: Actually, we will
16 give you some paperwork.

17 MS. WILKEY: Okay.

18 CHAIRPERSON MILLER: And that's it for
19 this case.
