CHAIRPERSON MILLER: The next case on our calendar is Case No. 12-AUD-00002, Armand's Chicago Pizzeria at 226 Massachusetts Avenue, N.E., License No. 75464 in ANC 6C.

Good morning. And when you're ready, could you introduce yourselves for the record, please?

MR. PARK: My name is Sungwok Park, vice-president of Armand's Pizzeria Capitol Hill.

MS. ZANIEL: And Maureen Zaniel on behalf of the District of Columbia.

CHAIRPERSON MILLER: Okay. This is a show cause status hearing. Mr. Park, did you receive notice of this hearing?

MR. PARK: Yes, ma'am.

CHAIRPERSON MILLER: Okay. Did you read it?

MR. PARK: Yes.

CHAIRPERSON MILLER: Did you

2 MR. PARK: Yes.

3 CHAIRPERSON MILLER: Okay.

4 MEMBER ALBERTI: Could you speak a

14 have discussed this and we'd like to recommend
15 an OIC to the Board, that the OIC consist of
16 a \$1,000 fine to be paid within 60 days.

17 CHAIRPERSON MILLER: Okay. Mr.
18 Park, it's been represented that there's an
19 Offer in Compromise for you to pay \$1,000
20 within 60 days to resolve this case.

21 MR. PARK: Yes, ma'am.

22 CHAIRPERSON MILLER: Are you

1 agreeable to that?

2 MR. PARK: Yes, ma'am.

3 CHAIRPERSON MILLER: And you know
4 that you waive your right to a hearing?

5 MR. PARK: Yes.

6 CHAIRPERSON MILLER: Okay. I
7 would move that we accept this Offer in
8 Compromise of \$1,000 payable within 60 days.

9 MEMBER MOBLEY: I second it.

10 CHAIRPERSON MILLER: Any comments?

11 (No audible response.)

12 CHAIRPERSON MILLER: All those

14 MEMBER MOBLEY: I second it.

15 CHAIRPERSON MILLER: Thank you.
16 There's a motion and it's been seconded. All
17 those in favor, say aye?

18 (Chorus of ayes.)

19 CHAIRPERSON MILLER: All those

22 CHAIRPERSON MILLER: All those

1 abstaining?

2 (No audible response.)

3 CHAIRPERSON MILLER: Then the vote
4 is 6-0-0 to accept the Offer in Compromise.
