3 CHAIRPERSON MILLER: All right. I
4 think we are ready for the last case of the
5 morning, which is Case No. 14-CMP-00700, Fuel
6 Pizza & Wings located at 1606 K Street, N.W.,
7 License No. 88452, in ANC-2B. When you are ready
8 if you would introduce yourselves for the record?

9 MS. GEPHARDT: Yes, Chrissy Gephardt
10 on behalf of the Office of the Attorney General.
11 Good morning.

12 MEMBER SHORT: Good morning.

13 CHAIRPERSON MILLER: Good morning.

14 MR. TABIEI: Omeed Tabiei, agent on
15 behalf of 1606 LLC.

16 MR. CONVERSE: Hi. I'm Doug Converse.
17 I'm the Director of Operations for Fuel Pizza &
18 Wings.

19 CHAIRPERSON MILLER: Okay. Okay.
20 This is a Show Cause Hearing. Are there any
21 preliminary matters?

22 MS. GEPHARDT: Yes, there is a

1 preliminary matter. We have an Offer in
2 Compromise that we would like to present to the
3 Board this morning.

4 CHAIRPERSON MILLER: Okay.

5 MS. GEPHARDT: There is one charge in
6 this case and for that we have agreed to an OIC
7 consisting of a \$2,000 fine and this would be
8 paid within 60 days. And if the fine is not paid
9 within 60 days, the license would be immediately
10 suspended.

11 CHAIRPERSON MILLER: Okay. Let me ask
12 the licensee if he is agreeable to that Offer in
13 Compromise of a \$2,000 fine payable within 60
14 days? If not paid within 60 days, the license
15 will be suspended until payment.

16 MR. CONVERSE: Yes.

17 CHAIRPERSON MILLER: Okay. And you
18 understand that you waive your right to a hearing
19 and to an appeal?

20 MR. CONVERSE: Yes.

21 CHAIRPERSON MILLER: Okay. Any
22 questions by Board Members? Okay.

1 Then I move that we approve this Offer
2 in Compromise of a \$2,000 fine payable within 60
3 days. If not paid within 60 days, the license
4 will be suspended until paid.

5 MEMBER RODRIGUEZ: Second it.

6 CHAIRPERSON MILLER: Mr. Rodriguez
7 seconded the motion.

8 All those in favor say aye.

9 MEMBER BROOKS: Aye.

10 CHAIRPERSON MILLER: Aye.

11 MEMBER RODRIGUEZ: Aye.

12 MEMBER SHORT: Aye.

13 MEMBER SILVERSTEIN: Aye.

14 CHAIRPERSON MILLER: All those
15 opposed?

16 MEMBER ALBERTI: Opposed.

17 CHAIRPERSON MILLER: All those
18 abstaining? The motion passes 5-1-0 with Mr.
19 Alberti opposed.

20 MS. GEPHARDT: Thank you.

21 CHAIRPERSON MILLER: Thank you. Okay.
