3 BOARD AGENT FLETCHER: Would the
4 parties in the matter of Walter Johnson Liquors
5 please come forward. This is Case No. 15-PRO-
6 00028. Richard Liquors t/a Walter Johnson Liquors,
7 1542 North Capitol Street, N.W., License No. ABRA-
8 075411. This is a retailer class A license
9 renewal. The protest includes an adverse impact
10 on peace, order and quiet and violation of the
11 settlement agreement.

12 My name is Laverne Fletcher and I'm
13 conducting the Roll Call Hearing as the Board's
14 agent pursuant to D.C. Official Code 1601.2.

15 Introductions, beginning with the
16 applicant.

17 MR. SUON: Hi, my name is Malay Suon
18 from Walter Johnson Liquors.

19 BOARD AGENT FLETCHER: And would you
20 spell that for me please.

21 MR. SUON: M-a-l-a-y S-u-on.

22 BOARD AGENT FLETCHER: What's the

1 first name?

2 MR. SUON: Malay M-a-l-a-y.

3 BOARD AGENT FLETCHER: Okay. And
4 what's the last name?

5 MR. SUON: S-u-o-n.

6 BOARD AGENT FLETCHER: Okay. And your
7 name, ma'am?

8 MRS. SUON: J-e-s-n-y S-u-o-n.

9 BOARD AGENT FLETCHER: And present on
10 behalf of ANC 5E?

11 MR. THOMAS: Bradley Thomas,
12 Commissioner for ANC 5E05 and vice chair of ANC
13 5E.

14 BOARD AGENT FLETCHER: Thank you, Mr.
15 Thomas. ANC 5E does have standing as a protestant
16 and we need to set a date for a mediation, a
17 status hearing and a protest hearing. I'll give
18 you the dates for the status and protest hearings
19 first. Mr. Suon, are you putting your contact
20 information on that sheet so that I can contact
21 you during the day?

22 MR. SUON: Okay.

1 BOARD AGENT FLETCHER: Okay. So the
2 status hearing is scheduled for June 17th at 9:30
3 a.m. That's the status hearing, June 17th at
4 9:30. And the protest hearing is set for July
5 22nd at 4:30.

6 MR. THOMAS: The 22nd?

7 BOARD AGENT FLETCHER: Yes. July 22nd
8 at 4:30. And you'll receive a notice about these
9 hearings by email, that's why I wanted you contact
10 information.

11 MR. THOMAS: Yes. I don't believe
12 we're going to have to get to a protest hearing
13 but, if we do, can that date be changed?

14 BOARD AGENT FLETCHER: If the date
15 needs to be changed then Mr. Thomas you would just
16 submit an email to our general counsel Martha
17 Jenkins and request that the date be changed. You
18 know Martha? Martha.jenkins@dc.gov.

19 MR. THOMAS: Okay.

20 BOARD AGENT FLETCHER: And you can
21 just send an email to Mr. Suon. And then Mr.
22 Thomas, as you know, if the matter is resolved

1 then we'll take it off--

2 MR. THOMAS: Yes.

3 BOARD AGENT FLETCHER: Same thing goes
4 for the mediation that we're about to schedule. If
5 you can resolve the matter before mediation then
6 we'll cancel that as well.

7 MR. THOMAS: But the protest is 1:30
8 p.m. 4:30?

9 BOARD AGENT FLETCHER: 4:30. July 22nd
10 at 4:30. We need to set a date for mediation
11 just in case we need it. The next available date
12 for mediation is Thursday, May 21st at 9, 10 or
13 11.

14 MR. SUON: At what time?

15 BOARD AGENT FLETCHER: At 9, 10 or 11.

16 MR. SUON: 10.

17 BOARD AGENT FLETCHER: 10 is good? So
18 the mediation is set for 10 o'clock on Thursday,
19 May 21. And if the matter is resolved before then
20 you can just let me know -- my card is on the
21 table -- and I'll cancel the mediation. Any
22 questions about that? The Roll Call Hearing

1 concludes.

2 MR. THOMAS: Thank you.

3 MR. SUON: Thank you.

4 (Whereupon, the Roll Call Hearing in
5 the above-entitled matter having been concluded,
6 went off the record at 10:27 a.m.)
