3 CHAIRPERSON MILLER: Okay. Number
4 two on the supplemental licensing agenda,
5 which was dated yesterday -- and we had
6 hearings yesterday, we're just picking up
7 today -- is a review of the licensee's renewal
8 status in the case of Twelve Restaurant and
9 Lounge, located at 1123 H Street, NE. License
10 Number 076366.

11 And we did review this yesterday.
12 And determined that a cease and desist order
13 was appropriate and signed it yesterday. But
14 I would move that we just put our vote on the
15 record on the agenda for a cease and desist
16 and order cancelling Twelve's license.

17 MEMBER RODRIGUEZ: Is that a
18 motion?

19 CHAIRPERSON MILLER: Yes. Okay,
20 this was a case where the Board -- the
21 applicant failed to appear at the roll call.
22 And was instructed that he should file a

1 Motion for Reinstatement within ten days. And
2 he did not file that Motion.

3 Okay, so do I have a second on
4 this Order to cease and desist? It's Order
5 Number 076366.

6 MEMBER RODRIGUEZ: I second the
7 Motion.

8 CHAIRPERSON MILLER: Okay, Mr.
9 Rodriguez has seconded the Motion. All those
10 in favor say aye.

12 CHAIRPERSON MILLER: All those
