CHAIRPERSON MILLER: Okay, next on our calender, I believe, is Case Number 12-CMP-00456 Mama Chuy. Located at 2620 Georgia Avenue Northwest, License Number 86892. Is anybody here on that case?

MS. SCHMIDT: The Government's here.

CHAIRPERSON MILLER: Okay. You want to introduce yourself for the record?

MS. SCHMIDT: Good morning, Amy Schmidt as Attorney General standing in for Walter Adams on behalf of the District of Columbia.

CHAIRPERSON MILLER: Okay. Do you have any information whether the Licensee may be on his or her way?

MS. SCHMIDT: No.

CHAIRPERSON MILLER: Okay, so --

MR. OROZCO: I apologize, I'm speaking to the gentleman when you called the

1 case.

2 CHAIRPERSON MILLER: Oh, that's
3 you.

4 MR. OROZCO: Yes, ma'am.

5 CHAIRPERSON MILLER: Okay, come on
6 forward, have a seat. And if you could
7 introduce yourself for the record please.

8 MR. OROZCO: My name is Jose
9 Orozco, I am the chef and one of the owners at
10 Mama Chuy DC.

11 CHAIRPERSON MILLER: Okay. And
12 whenever chance if you could sign that piece
13 of paper so we get your spelling of your name
14 right. So I want to ask you if you received
15 notice of this hearing?

16 MR. OROZCO: I did received
17 notice. I was a little bit surprised about
18 the way I received it because I mailed in, I
19 don't know if you have the record because I
20 was contacted by, I believe the U.S. Attorney,
21 a couple days ago. And they only had on file
22 one violation, I believe, before we opened.

1 We didn't realize we needed to
2 file, it took us longer to open than we
3 anticipated and we didn't initially file on
4 time. We actually missed two of them.

5 I after, I believe I was served
6 with the first one on August 13th, 2012, at
7 2:00 p.m. And I responded two days later by
8 mail.

9 CHAIRPERSON MILLER: Okay, we
10 don't want to get too much into the merits of
11 the case yet.

12 MR. OROZCO: Oh, okay.

13 CHAIRPERSON MILLER: Because this
14 is just the status, this isn't the --

15 MR. OROZCO: I guess my point is,
16 I never received any type of mail or a call
17 about a hearing until I received this. So I
18 was under the assumption that I would receive
19 something before this came in. Someone came
20 in and hand delivered it to me.

21 CHAIRPERSON MILLER: When did you
22 get notice?

1 MR. OROZCO: This notice I
2 received on, oh here it is, it is on the 10th
3 of the previous month.

4 CHAIRPERSON MILLER: Okay.

5 MS. SCHMIDT: I've just informed
6 the Licensee that Mr. Adams would be glad to
7 speak to him about this matter and we do not
8 have OIC for this morning so we can just
9 continue this for a hearing.

10 CHAIRPERSON MILLER: Okay. All
11 right, so I want to at least make sure that
12 you received notice so that, you did receive
13 it and you read it?

14 MR. OROZCO: I did received this
15 hand delivered one.

16 CHAIRPERSON MILLER: Okay.

17 MR. OROZCO: I received it last
18 month.

19 CHAIRPERSON MILLER: All right.
20 Do you understand it?

21 MR. OROZCO: I do understand it.

22 CHAIRPERSON MILLER: Okay, so

1 we're going to make that notice a part of the
2 record without objection. And we'll set this
3 for the hearing on the merits for July 3rd,
4 2013 at 10 o'clock a.m.

5 And my understanding from Ms.
6 Schmidt is that before then you will have a
7 chance to talk with the Government's Attorney.

8 MR. OROZCO: Okay.

9 CHAIRPERSON MILLER: To see
10 whether you settle or whatever.

11 MR. OROZCO: Okay.

12 CHAIRPERSON MILLER: Okay, all
13 right. Thank you very much.

14 MR. OROZCO: Thank you.
