4 the record with the Agenda for May 16, 2012.

6 alcohol operation and hours of alcoholic  
7 beverage sales/service on premises on Saturday  
8 are 11:00 a.m. until 3:00 a.m.; Sunday 11:00  
9 a.m. to 2:00 a.m.

10 The proposed Saturday and Sunday  
11 hours of operation and hours of alcoholic  
12 beverage sales/service on premises would be  
13 10:00 a.m. to 3:00 a.m. and Sunday 10:00 a.m.  
14 to 2:00 a.m. That's Saturday 10:00 a.m. to  
15 3:00 a.m. and Sunday 10:00 a.m. to 2:00 a.m.

16 And the current Saturday and  
17 Sunday hours of operation are of alcoholic  
18 beverage sales/services with summer garden  
19 would be -- are Saturday and Sunday 11:00 a.m.  
20 to 12:00 a.m. The proposed would be Saturday  
21 and Sunday 10:00 a.m. to 12:00 a.m.

22 There are no investigative matters

1 pending, no outstanding citations or fines, no  
2 conflict with amendment to voluntary  
3 agreement. The ANC has agreed to this.

4 Therefore, i would recommend  
5 approval. Do I have a second?

6 MEMBER NOPHLIN: Second.

3 Okay. No pending investigative

5 agreement. It is for Rock Creek Market, 644-  
6 646 Rock Creek Church Road, N.W., License No.  
7 83203.

8 Street, N.W., License No. 80899.

10 for Capital Eagle, Inc. to ship and store  
11 products at Georgetown University for an  
12 event.

13 This is for Capital Eagle, Inc.  
14 located at 2815 V Street, N.E., License No.  
15 26023.

16 I would move that we approve this

13                   MEMBER ALBERTI: Is this Item No.  
14       7?

15                   CHAIRPERSON MILLER: Yes.

16                   MEMBER ALBERTI: My recommendation  
17       is that we postpone this for one week.
