21 AGENT FLETCHER: And, Ms. Staples,

22 are you here on behalf of Range?

1 MS. STAPLES: Yes.

2 AGENT FLETCHER: Okay. Thank you
3 for coming.

4 The -- you're aware of this
5 already. This is just going to be for the
6 record that I make this statement. The
7 protest is dismissed because the Protestants
8 contacted me last week to say that they're not
9 going to appear today because they're going to
10 withdraw -- their intention was to withdraw
11 the protest, but what they decided to go ahead
12 and do is just be dismissed today.

13 They realized that if they were
14 not here today, the protest would be dismissed
15 because they intend to not pursue the protest
16 against the license renewal because they came
17 to some understanding with the Licensee, and
18 so, for the purpose of the Roll Call Hearing,
19 the protest is dismissed.

20 And, the Protestants will receive
21 order of dismissal and they'll have ten days
22 to seek reinstatement of the protest if they

1 wish to, but my understanding is that they
2 have no intention of doing that and that is
3 the reason that they're not present today.

4 And, Ms. Staples, would you please
5 put your name and email address? But, one
6 other thing. You would normally be at that
7 table, so if you could just put your name and

9 your daytime telephone number.
