AGENT FLETCHER: Are the parties present in the matter of Union Liquors? The parties in the matter of Union Liquors? This is Trabra, Incorporated, trading as Union Liquors, Case Number 12-PRO-00029, 1537 Good Hope Road SE, License Number ABRA-0079922. This a Retailer Class A, License Renewal Application. The protest issues are adverse impact on peace, order, and quiet.
