3 AGENT FLETCHER: Would the parties in
4 the matter of Minnesota Liquors, please, come
5 forward? The parties in the matter of Minnesota
6 Liquors? This is Case No. 15-PRO-00044, Bob-kat,
7 Inc. t/a Minnesota Liquors, 2237 Minnesota
8 Avenue, S.E., License No. ABRA-000222. This is a
9 Retailer Class A License renewal.

10 The protest issues are adverse impact
11 on peace, order and quiet and parking.

12 My name is LaVerne Fletcher. I'm
13 conducting the Roll Call Hearing as the Board's
14 Agent pursuant to D.C. Official Code 1601.2.

15 Introductions beginning with Minnesota
16 Liquors.

17 MS. CHUNG: He's my dad.

18 MR. CHUNG: Hae Yun Chung.

19 AGENT FLETCHER: Okay. Can you speak
20 a little louder? We have got a lot of noise back
21 here today. I'm sorry. And into the microphone,
22 that would be helpful.

1 MR. CHUNG: Hae Chung.

2 AGENT FLETCHER: Okay. Can you help
3 me with that? I can't hear.

4 MR. CHUNG: Hae Chung. H-A-E.

5 AGENT FLETCHER: Okay. H-A?

6 MR. CHUNG: H-A-E.

7 AGENT FLETCHER: E, yes. H-A-E.

8 MR. CHUNG: Yes. Okay. Chung, C-H-U-
9 N-G.

10 AGENT FLETCHER: Chung is the last
11 name, C-H-U-N-G?

12 MR. CHUNG: Yes.

13 AGENT FLETCHER: Okay. And, Mr.
14 Chung, I'm going to ask you to write your name.

15 MS. CHUNG: I already did.

16 AGENT FLETCHER: You already did?

17 MS. CHUNG: Yes.

18 AGENT FLETCHER: Okay. Then that is
19 perfect.

20 Mr. Chung, are you the owner?

21 MR. CHUNG: Yes.

22 AGENT FLETCHER: And, Mr. Chung, is

1 your telephone number and email address also on
2 that sheet?

3 MS. CHUNG: We don't have Internet, so
4 we --

5 AGENT FLETCHER: Oh, that's okay.

6 MS. CHUNG: -- just put our phone
7 number.

8 AGENT FLETCHER: You got the phone
9 number?

10 MS. CHUNG: Yes.

11 AGENT FLETCHER: Okay. Can I get you
12 name, ma'am?

13 MS. CHUNG: Jennifer and same last
14 name.

15 AGENT FLETCHER: What's the first
16 name?

17 MS. CHUNG: Jennifer.

18 AGENT FLETCHER: Jennifer?

19 MS. CHUNG: Yes.

20 AGENT FLETCHER: Jennifer Chung?

21 MS. CHUNG: Yes.

22 AGENT FLETCHER: And so, Jennifer

1 Chung, are you going to put your name and address
2 on that sheet as well? We're going to contact
3 you directly, Mr. Chung.

4 MS. CHUNG: Yes.

5 AGENT FLETCHER: Okay. And you're
6 just here with Mr. Chung?

7 MS. CHUNG: Yes.

8 AGENT FLETCHER: Okay. Thank you.

9 Present on behalf of ANC-8A?

10 MS. SIMMS: Cynthia Simms,
11 Commissioner of ANC-8A03 representing the
12 commission and also for Holly Muhammad, which is
13 ANC-8A01.

14 AGENT FLETCHER: Thank you, Ms. Simms.
15 The last name is S-I-M-M-S?

16 MS. SIMMS: Yes.

17 AGENT FLETCHER: Thank you.

18 MS. FLETCHER: Tina Fletcher, ANC
19 Commissioner for 8A06. Last name F-L-E-T-C-H-E-
20 R.

21 AGENT FLETCHER: Thank you, Ms.
22 Fletcher. ANC-8A does have standing as a

1 protestant.

2 We need to set a date for a mediation,
3 Status and Protest Hearing. I'll give you the
4 date for the Status and Protest Hearing first.

5 The date of the Status Hearing is July
6 15. July 15 at 9:30.

7 MS. CHUNG: Do we have a choice of
8 this time or we don't have a choice for the time?

9 AGENT FLETCHER: I'm sorry, I can't
10 hear you.

11 MS. CHUNG: Do we have a choice to
12 change the time?

13 AGENT FLETCHER: No. It's always at
14 9:30.

15 MS. CHUNG: Oh.

16 AGENT FLETCHER: Yes. 9:30 a.m. for
17 the Status Hearing.

18 MS. SIMMS: What was the date?

19 AGENT FLETCHER: But, Ms. Chung, they
20 don't last a long time. Just so that you know,
21 they go by pretty fast, if that helps.

22 The date of the Protest Hearing is

1 September 16 at 1:30 p.m.

2 We need to set a date for mediation.
3 The next available date for mediation is Friday,
4 June 26 at 9:00, 10:00 or 11:00. Do you have a
5 preference, Ms. Simms?

6 MS. SIMMS: 11:00 is fine if that's
7 okay with you all.

8 MS. CHUNG: Yes, 11:00 is good.

9 AGENT FLETCHER: Is 11:00 okay?

10 MS. SIMMS: You said June 26th?

11 AGENT FLETCHER: Yes, Friday, June 26
12 at 11:00 for Minnesota Liquors.

13 MS. SIMMS: Ms. Fletcher, in the
14 meantime, we will reach out to Mr. Chung to try
15 to come to some kind of agreement before that
16 time.

17 AGENT FLETCHER: Thank you. Thank
18 you, Ms. Simms. So if I need to cancel
19 mediation, just let me know.

20 Well, thank you for coming. The Roll
21 Call Hearing is concluded.

22 Ms. Fletcher, you can stay there. The

1 next case is your's.

2 Ms. Simms, are you also representing
3 Sunny's?

4 MS. SIMMS: With Ms. Fletcher. I mean
5 with --

6 AGENT FLETCHER: You are representing
7 Sunny's Liquor also, Ms. Simms?

8 MS. SIMMS: Yes.

9 AGENT FLETCHER: Okay.

10 MS. SIMMS: Along with Ms. Fletcher.

11 AGENT FLETCHER: Okay. Thank you.

12 The Roll Call Hearing is concluded in the matter
13 of Minnesota Liquors.
