3 MS. FLETCHER: Parties in the
4 matter of Capitol Skyline Hotel. Are the
5 parties present in the matter of Capitol
6 Skyline Hotel?

7 This is Case No. 12-PRO-00052,
8 Capital Hospitality, LLC, trading as Capitol
9 Skyline Hotel, 10 I Street, S.W., License No.
10 ABRA-072534. This is a Retailers CH License
11 Renewal.

12 The protest issues are adverse
13 impact on peace, order and quiet.

14 My name is La Verne Fletcher and
15 I'll be conducting the Roll Call Hearing as
16 the Board agent, pursuant to D.C. Official
17 Code 1601.2.

18 Introductions, beginning with the
19 -- with ANC6D.

20 MS. ROLE: Hello. My name is
21 Susan Eads Role, and I'm here on behalf of
22 ANC6D.

1 MS. FLETCHER: Thank you, Ms.
2 Role. Would you spell your name for the court
3 reporter, please.

4 MS. ROLE: Yes. It's S-u-s-a-n.
5 Middle name Eads, E-a-d-s. Last name Role, R-
6 o-l-e.

7 MS. FLETCHER: Thank you, Ms.
8 Role. And has ANC6B been in communication
9 with the establishment? Is there a voluntary
10 agreement or cooperative agreement?

11 MS. ROLE: Yes. The chairwoman of
12 our ABC committee, Kyra Shockley, has been in
13 touch with the applicant and it is my
14 understanding that there is progress towards
15 reaching a settlement agreement.

16 MS. FLETCHER: For the purpose of
17 the roll call hearing, I'm going to dismiss
18 the license renewal application because the
19 Applicant failed to appear.

20 But, Ms. Role, as you probably
21 know, you can continue with your efforts to
22 resolve the matter by way of a cooperative

1 agreement and, if that is submitted to the ABC
2 Board for review, it can still be approved.

3 MS. ROLE: Thank you.

4 MS. FLETCHER: But, for the
5 purpose of the Roll Call Hearing, the license
6 application is dismissed.

7 Ms. Role, do you have your contact
8 information on that sheet?

9 MS. ROLE: Yes. I just placed it
10 there.

11 MS. FLETCHER: Okay. Thank you
12 very much.

13 The Roll Call Hearing is
14 concluded. Thank you for coming. And you've
15 got another case coming up. Don't you?

16 MS. ROLE: I do.

17 MS. FLETCHER: So I'll just call
