3 MS. FLETCHER: Would the parties  
4 in the matter of Corina's Restaurant please  
5 come forward.

6 That's Corina's Restaurant, Case  
7 No. 13-PRO-00054, Garay Corporation, trading  
8 as Corina's Restaurant, 831 Kennedy Street,  
9 N.W., License No. ABRA-079873. This is a  
10 Retailer CR License Renewal.

11 The protest issues are adverse  
12 impact on peace, order and quiet.

13 My name is La Verne Fletcher and  
14 I'll be conducting the Roll Call Hearing as  
15 the Board's agent pursuant to D.C. Official  
16 Code 1601.2.

17 Introductions beginning with the  
18 applicant, please.

19 MS. GARAY: My name is Sylvia  
20 Garay.

21 MS. FLETCHER: Would you spell  
22 that, please.

1 MS. GARAY: First name is S-y-l-v-  
2 i-a. Last name, G-a-r-a-y.

3 MS. FLETCHER: Thank you.

4 And your name, ma'am.

5 MS. GARMANY: Sandra Garmany, S-a-  
6 n-d-r-a, G-a-r-m-a-n-y.

7 MS. FLETCHER: Thank you.

8 And your name, ma'am?

9 MS. GARAY: My name is Corina  
10 Garay.

11 MS. FLETCHER: Would you spell the  
12 first name?

13 MS. GARAY: I can spell that for  
14 my mother.

15 MS. FLETCHER: Oh, sure. Thank  
16 you.

17 MS. GARAY: C-o-r-i-n-a.

18 MS. FLETCHER: Thank you. And G-  
19 a-r-a-y.

20 MS. GARAY: Same last name. Yes,  
21 ma'am.

22 MS. FLETCHER: Okay. Is there

1 anyone present on behalf of ANC4D?

2 (No response.)

3 MS. FLETCHER: ANC4D is dismissed  
4 as a protestant. The time is approximately  
5 11:19, and no one is present from ANC4D.

6 Ms. Garay, did you want to say  
7 something?

8 MS. GARAY: No. I'm just --

9 MS. FLETCHER: Oh, okay. Thank  
10 you. I thought you wanted to say something.

11 So, ANC4D is dismissed as a  
12 protestant, and they will be issued an order  
13 from the ABC Board, dismissing the protest.  
14 They will have ten days from that time to seek  
15 standing as a protestant.

16 They would have to explain to the  
17 ABC Board why they were not here today and if  
18 the ABC Board accepts that explanation, they  
19 can decide to grant them standing as a  
20 protestant, and you will be informed if that  
21 happens.

22 And you will also have an

1 opportunity to respond to any request that  
2 they make to be granted as a protestant.

3 But, for the purpose of the Roll  
4 Call Hearing today, ANC4D does not have  
5 standing as a protestant. That means there is  
6 no protest -- no valid protest as of today.

7 MS. GARAY: Good.

8 MS. FLETCHER: But they will have  
9 an opportunity to explain why they weren't  
10 here and to ask the Board if they will grant  
11 them standing, and they may or they may not.  
12 But, they will let you know.

13 MS. FLETCHER: Okay. Thank you.

14

15 MS. GARMANY: All right.

16 MS. FLETCHER: Thank you very much.

17 MS. GARMANY: Thank you, Ms.

18 Fletcher.

19 MS. FLETCHER: Appreciate it. The  
20 Roll Call Hearing is concluded. Thank you.
