3 MS. FLETCHER: Would the parties
4 in the matter of The Scene come forward. The
5 parties in the matter of The Scene.

6 This is Case No. 13-PRO-00064, M-
7 P-A-C, LLC, trading as The Scene, 2221 Adams
8 Place, N.E., License No. ABRA-078642. This is
9 a Retailer CX License Renewal.

10 The protest issues are adverse
11 impact on peace, order and quiet.

12 My name is La Verne Fletcher and I
13 am conducting the Roll Call Hearing as the
14 Board's agent, pursuant to D.C. Official Code
15 1601.2.

16 Is there anyone present in the

21 spell that for the record.

22 MR. BLAKENEY: W-i-l-l-i-e, B-l-a-

2 MS. FLETCHER: B-l-a-k-e-n-e-y?

3 MR. BLAKENEY: Yes.

4 MS. FLETCHER: Thank you. So, Mr.
5 Blakeney, have you entered into a cooperative
6 agreement with ANC5C?

7 MR. BLAKENEY: No, ma'am, I have
8 not.

9 MS. FLETCHER: Okay. Thank you.
10 ANC5C is dismissed as a protestant
11 for failure to appear.

12 And, Mr. Blakeney, ANC5C will
13 receive an order dismissing it as a
14 protestant, and they will have ten days to
15 seek standing as -- as a protestant from the
16 ABC Board.

17 If they do that, you will be
18 informed that they have sought standing.
19 They've been dismissed as of today. So, as of
20 today, there is no protest.

21 If they seek standing as a
22 protestant, you will receive notice of that

1 and have an opportunity to respond to it.

2 MR. BLAKENEY: Okay.

3 MS. FLETCHER: Do you have your
4 daytime contact information?

5 MR. BLAKENEY: Yes, I do.

6 MS. FLETCHER: Okay. Thank you
7 very much. The Roll Call Hearing is
8 concluded. Thank you.
