CHAIRPERSON MILLER: Okay. We are back on the record for Case No. 12-CMP-00613, Sunset Liquors located at 1627 1st Street, N.W., License No. 60657, in ANC-5E.

Are the parties here for that case? Would you come forward, please? Have a seat at the table. If you could identify yourself for the record?

MR. SINGH: My name is Shabegg Singh, a representative of Carnival, Inc.

CHAIRPERSON MILLER: Could you spell your last name?

MR. SINGH: S-I-N-G-H, Shabegg, S-H-A-B-E-G-G, Shabegg.

CHAIRPERSON MILLER: Okay. And are you the owner?

MR. SINGH: Yes, ma'am.

CHAIRPERSON MILLER: Okay. And also, if you can sign in on that piece of paper right there? Thank you. So that the

1 court reporter makes sure your spelling of
2 your name is correct. Okay.

3 And for the Government?

4 MS. SCHMIDT: Amy Schmidt,
5 Assistant Attorney General, on behalf of the
6 District of Columbia.

7 CHAIRPERSON MILLER: All right.
8 So this is a Show Cause Hearing. Are there
9 any preliminary matters?

10 MS. SCHMIDT: Yes, there is. We
11 have an offer in compromise which we would
12 like to present to the Board right now.

13 That offer in compromise is a \$500
14 fine to be paid within 30 days and there is --
15 and then there is a three day suspension
16 coming from -- emanating from Case No. 11-CMP-
17 00336 and those three days will be served on
18 the 17th, 18th and 19th of June.

19 CHAIRPERSON MILLER: Okay. Now,
20 is that agreeable to you that this is an offer
21 in compromise to settle the case for \$500 and
22 also there will be three days suspended which

1 are triggered from previous Case No. 00336?

2 MR. SINGH: Yes, ma'am.

3 CHAIRPERSON MILLER: Yes? Okay.

4 And when will the \$500 be paid?

5 MS. SCHMIDT: Within 30 days.

6 CHAIRPERSON MILLER: Within 30
7 days.

8 MR. SINGH: I agree.

9 CHAIRPERSON MILLER: Okay. All
10 right. Are there any questions by Board
11 Members? Okay. I move that we accept this
12 offer in compromise of \$500 to be paid within
13 30 days.

14 MEMBER SILVERSTEIN: Second.

15 CHAIRPERSON MILLER: Okay. But
16 also that there will be a three day suspension
17 of the license on June 17, 18 and 19 triggered
18 by a previous Case No. 00336.

19 MEMBER SILVERSTEIN: Second.

20 CHAIRPERSON MILLER: Mr.
21 Silverstein has seconded the motion.
