3 CHAIRPERSON MILLER: The next case
4 on our calendar is Case No. 11-CMP-00420, Cafe
5 Citron, 1343 Connecticut Avenue, N.W., License
6 No. 60138.

7 MR. BIANCO: Good morning, Richard
8 Bianco on behalf of the licensee.

9 CHAIRPERSON MILLER: Good morning.

10 MS. BERINDOAGUE: Clelia
11 Berindoague. I'm the applicant, Cafe Dupont
12 t/a Cafe Citron.

13 MR. SEMORILE: Jose Semorile on
14 behalf of Cafe Citron.

15 MR. STERN: Michael Stern
16 representing the District of Columbia.

17 CHAIRPERSON MILLER: Okay. This
18 is a Show Cause (Status) Hearing, so Mr.
19 Bianco, I want to ask your clients whether
20 they received notice of the hearing?

21 MR. BIANCO: We have and we'll
22 waive reading and I believe the Government has

1 an offer in compromise.

2 CHAIRPERSON MILLER: And they
3 understand the notice?

4 MR. BIANCO: Yes.

5 CHAIRPERSON MILLER: Okay.

6 MR. STERN: Yes, the parties have
7 agreed to resolve this case -- excuse me, that
8 to resolve this case, we will present an offer
9 in compromise if the Board will truly -- we
10 hope the Board will accept.

11 The respondent will pay a fine of
12 \$750 within 30 days.

13 CHAIRPERSON MILLER: Okay. All
14 right. Let me repeat this back then. Mr.
15 Bianco, it's an offer in compromise for paying
16 \$750 within 30 days.

17 MR. BIANCO: Yes, that's correct.
18 Actually, it was our understanding that it
19 would be payable today, so we are prepared --

20 CHAIRPERSON MILLER: Today?

21 MS. BUSHMAN: -- to pay it today.

22 CHAIRPERSON MILLER: Good. We

1 prefer that. Okay. All right. Anything else
2 you want to say to the offer?

3 MR. BIANCO: No.

4 CHAIRPERSON MILLER: Okay. Any
5 questions? All right.

6 Then I would move to accept the
7 offer in compromise of \$750 to be paid today.
8 Do I have a second?

9 MEMBER NOPHLIN: Second.

10 CHAIRPERSON MILLER: Any other
11 comments?

12 All those in favor of the motion
13 to accept this offer in compromise, say aye.

14 ALL: Aye.

15 CHAIRPERSON MILLER: All those
16 opposed? All those abstaining? And the vote
17 is 6-0-0 to accept the offer in compromise.

18 MR. BIANCO: Thank you. Madam
19 Chair, Members of the Board, have a nice day.

20 CHAIRPERSON MILLER: Thank you,
21 you, too.
