CHAIRPERSON MILLER: All right. I'm going to begin with the Members that we have here. Good morning. I would like to welcome you to the regularly scheduled meeting of the District of Columbia Alcoholic Beverage Control Board.

Today is June 10, 2015. My name is Ruthanne Miller. I'm the Chairperson. Joining me to my far right is Mr. Donald Brooks. Next to Mr. Brooks is Mr. Rodriguez. And to my left is Mr. James Short. We have four Members in attendance for the conduct of business this morning with two joining us shortly and three constitutes a quorum.

Copies of today's hearing calendar and agenda are available at the receptionist desk. Please be aware that these proceedings are being recorded by a court reporter. Accordingly, we must ask you to refrain from any disruptive noises or actions in the hearing room.

1 If you have any electronic devices,
2 pagers, cell phones or such, please, make certain

4 the proceedings.

5 When I call your case, please, come
6 forward and take a seat at one of the tables in
7 the front. You will note that there is a piece
8 of paper on each table for you to sign-in. This
9 is to ensure the correct spelling of your name
10 for the record.

11 The Open Meetings Act requires that
12 the public hearing on each case be open to the
13 public. The Board may, consistent with Section
14 405(b) of the Open Meetings Act, enter a closed
15 meeting during or after the public hearing on a
16 case to consult with an attorney to obtain legal
17 advice, discuss settlement agreements or
18 deliberate upon a decision in an adjudication
19 proceeding.

20 And we have just been joined by
21 Members Mr. Nick Alberti on my right and Mr. Mike
22 Silverstein on my left.

1 And we are now ready to proceed with
2 this morning's calendar.

3 The first case is Case No. 15-CMP-
4 00127, The Showtime located at 113 Rhode Island
5 Avenue, N.W., License No. 89186, in ANC-5E.

6 Would the parties introduce themselves
7 for the record?

8 MS. GEPHARDT: Chrissy Gephardt here
9 on behalf of the Office of the Attorney General
10 for the District of Columbia.

11 CHAIRPERSON MILLER: Okay. Is anybody
12 here from Showtime? Ms. Gephardt, do you have
13 any word whether the licensee is on his or her
14 way?

15 MS. GEPHARDT: No. I have no
16 knowledge of that.

17 CHAIRPERSON MILLER: Okay. So what I
18 think I'll do is I'll set this case for a Show
19 Cause Hearing on July 22, 2015 at 10:00 a.m. And
20 if someone appears and you have reason to come
21 back before us, we could entertain it then.

22 MS. GEPHARDT: Okay.

2 this case is scheduled for Show Cause Hearing.
