Room, Reeves Building, 2000 14th Street, N.W.,
Suite 400S, Washington, D.C. 20009, Ms. LaVerne
Fletcher, Agent, presiding.

3 AGENT FLETCHER: Would the parties in
4 the matter of Kovaks Liquors, please, come
5 forward? The parties in the matter of Kovaks
6 Liquors. This is Case No. 15-PRO-00051, KYS,
7 Inc. t/a Kovaks Liquors, 1237 Mount Olivet Road,
8 N.E., License No. ABRA-076573. This is a
9 Retailer Class A License Renewal.

10 The protest issues are adverse impact
11 on peace, order and quiet.

12 My name is Laverne Fletcher. I'm
13 conducting the Roll Call Hearing as the Board's
14 Agent pursuant to D.C. Official Code 1601.2. Is
15 the applicant present?

16 MS. KIM: I'm here to represent my
17 father.

18 AGENT FLETCHER: I'm sorry?

19 MS. KIM: I'm here to represent my
20 father on his behalf. I have a written
21 statement.

22 AGENT FLETCHER: Oh, you are the --

1 your father is the applicant?

2 MS. KIM: He is the --

3 AGENT FLETCHER: He is the licensee,
4 the license holder?

5 MS. KIM: Yes.

6 AGENT FLETCHER: Okay. You are
7 actually going to be on that side. Thank you.
8 I'll take that. That's a Letter of Designation?

9 MS. KIM: Yes.

10 AGENT FLETCHER: I'll take that.
11 Thank you. Thank you very much.

12 MS. KIM: Thank you.

13 AGENT FLETCHER: And so, Ms. Kim,
14 would you state your name and spell it for the
15 record, please?

16 MS. KIM: Elina Kim. E-L-I-N-A last
17 name Kim, K-I-M.

18 AGENT FLETCHER: Is anyone present
19 from ANC-5D?

20 Ms. Kim, have you been in
21 communication with ANC-5D?

22 MS. KIM: Yes, we have.

1 AGENT FLETCHER: So is there a
2 settlement agreement or what's going on?

3 MS. KIM: We have an agreement. Our
4 SMD Commissioner since the beginning of -- since
5 probably March this year to try and get a renewed
6 settlement agreement.

7 MS. BUGGS: Good morning, Commissioner
8 Yvonne Buggs and I'm with the ANC-5D. I don't
9 see any other ANC-5D Commissioners here, so I
10 guess I have been --

11 AGENT FLETCHER: So what's your name
12 again?

13 MS. BUGGS: Yvonne Buggs.

14 AGENT FLETCHER: And, Ms. Buggs, would
15 you spell your name?

16 MS. BUGGS: B-U-G-G-S.

17 AGENT FLETCHER: And you are a
18 commissioner with the ANC-5D?

19 MS. BUGGS: Yes, ma'am.

20 AGENT FLETCHER: All right. You can
21 have a chair.

22 ANC-5D did not designate a

1 representative, but we can accept you as the
2 representative of ANC-5D.

3 MS. BUGGS: Okay.

4 AGENT FLETCHER: So you are the
5 designated representative.

6 MS. BUGGS: Okay.

7 AGENT FLETCHER: We are going to ask
8 Ms. Henderson to, unless she walks in, send us a
9 letter designating you as the representative.

10 MS. BUGGS: Okay.

11 AGENT FLETCHER: Okay. So I'm going
12 to grant standing to ANC-5D as a protestant.
13 Would you, please, put your contact information
14 on that sheet?

15 MS. BUGGS: Okay.

16 AGENT FLETCHER: And, Ms. Kim, if you
17 would do the same?

18 MS. KIM: Sure.

19 AGENT FLETCHER: I don't have dates
20 available for the Status Hearing today, but the
21 Status Hearing is going to be around July 15.
22 You will get an official notice about that, but

1 so the only date we are going to set today is the
2 date for mediation.

3 The next available date for mediation
4 is Monday, July 6th at 1:00 in the afternoon or
5 July 9 at 9:00, 10:00, 11:00 or 1:00. So would
6 you prefer to come during the morning?

7 MS. BUGGS: I'm sorry, say the date
8 again.

9 AGENT FLETCHER: Monday, July 6 at
10 1:00 in the afternoon.

11 MS. BUGGS: Okay.

12 AGENT FLETCHER: Or if you would
13 prefer to come in the morning, Thursday, July 9
14 is available at 9:00, 10:00 or 11:00.

15 MS. KIM: Could we do the 9:00,
16 please.

17 COURT REPORTER: Could you turn your
18 microphone on, please.

19 MS. KIM: I'm sorry.

20 MS. BUGGS: July 9th is okay.

21 AGENT FLETCHER: What time, Ms. Kim?

22 MS. KIM: I'm sorry. What time are

1 you available?

2 AGENT FLETCHER: 9:00, 10:00 or 11:00.

3 MS. KIM: Can we do 9:00? Is that
4 okay?

5 MS. BUGGS: 9:00.

6 MS. KIM: The 9th at 9:00?

7 AGENT FLETCHER: So mediation is set
8 for July 9 at 11:00.

9 MS. BUGGS: At -- did you say 11:00?

10 AGENT FLETCHER: Did you say -- Ms.
11 Kim, you did say 11:00, yes?

12 MS. KIM: 9:00.

13 AGENT FLETCHER: Did you say 9:00?

14 MS. KIM: Yes.

15 AGENT FLETCHER: 9:00. So mediation
16 is set for July 9 at 9:00. Thank you. The Roll
