3 MS. FLETCHER: Would the parties
4 in the matter of UMaya please come forward?

5 MR. ZHOU: Yes.

6 MS. FLETCHER: Thank you. This
7 is case number 14-PRO-00039, Zhou
8 Hospitality Group, LLC, trading as UMaya,
9 733 10th Street, Northwest, License Number
10 ABRA-94099.

11 This is a Retailer CT New
12 Application. The protest issues are adverse
13 impact on peace, order, and quiet.

14 My name is LaVerne Fletcher, and
15 I am conducting the roll call hearing as the
16 Board's agent pursuant to D.C. Official Code
17 1601.2

18 Introductions, beginning with the
19 applicant, please? Your name, sir?

20 MR. ZHOU: My name is Charles,
21 last name is Z-H-O-U, and I'm the applicant.

22 MS. FLETCHER: Z-H-O-U?

1 MR. ZHOU: Yes.

2 MS. FLETCHER: Thank you, Mr.
3 Zhou.

4 MR. MATTHEWS: Jermaine Matthews,
5 agent for the applicant.

6 MS. FLETCHER: And, Mr. Matthews,
7 would you spell your name for the record?

8 MR. MATTHEWS: J-E-R-M-A-I-N-E,
9 M-A-T-T-H-E-W-S.

10 MR. ZHOU: And my attorney is Ely
11 Hurwitz. He is not available today, so he -
12 - but he will still be handling the matter.

13 MS. FLETCHER: Okay, thank you.
14 And I'll spell Mr. Hurwitz's name for the
15 record. Ely is E-L-Y, and the last name is
16 Hurwitz, H-U-R-W-I-T-Z.

17 MR. ZHOU: That's correct.

18 MS. FLETCHER: Thank you. And
19 for ANC-2C?

20 MR. TINPE: Hello, I'm ANC-2C --

21 COURT REPORTER: Can you just
22 turn your mic on?

1 MS. FLETCHER: Sorry, yes,
2 there's a --

3 MR. TINPE: Hello, my name is
4 John Tinpe, J-O-H-N, last name spelled
5 Tinpe, T-I-N-P-E, T for tango, I for India,
6 N for Nancy, P for papa, E for echo.

7 And I'm representing ANC-2C.

8 MS. FLETCHER: Okay, thank you,
9 Mr. Tinpe. ANC-2C does have standing as a
10 protestant.

11 We need to set a date for
12 mediation, a status hearing, and a protest
13 hearing. I'll give you the dates for the
14 status hearing and protest hearing first.

15 The status hearing is set for
16 July the 9th at 9:30 a.m. July 9 at 9:30.
17 The protest hearing is set for August 6th at
18 1:30. That's August 6 at 1:30.

19 We need to set a date for
20 mediation to occur prior to July the 9th,
21 and I'll give you some dates that are
22 available. The next available date is June

1 the 26th, which is next Thursday, at 9, 10,
2 or 11, if that works for anyone, and the
3 27th is also available, that Friday at 9,
4 10, 11.

5 MR. TINPE: Excuse me, Ms.
6 Fletcher?

7 MS. FLETCHER: Yes.

8 MR. TINPE: On the 26th I have a
9 hearing with the Historic Preservation at
10 9:00 a.m., so I would request for June 27th,
11 Friday. Thank you.

12 MS. FLETCHER: Okay. So that
13 would be Friday at 9, 10, or 11.

14 MR. ZHOU: June 27th? Can we do
15 it at 11?

16 MS. FLETCHER: We can. That work
17 for you, Mr. Tinpe, as well?

18 MR. TINPE: Yes, it does. Thank
19 you.

20 MS. FLETCHER: And, Mr. Matthews,
21 does that work for you?

22 MR. MATTHEWS: It works for me.

1 MS. FLETCHER: Mr. Matthews, did
2 you say that will work for you?

3 MR. MATTHEWS: Yes --

4 MS. FLETCHER: Okay, that's
5 perfect, thank you. Then mediation is set
6 for Friday, June 27 at 11. And, Mr. Zhou
7 and Mr. Matthews, would you put your contact
8 information on that sheet?

9 MR. ZHOU: Yes, ma'am.

10 MS. FLETCHER: Thank you.

11 Mr. Tinpe, I think that's what
12 you're doing now, right?

13 MR. TINPE: Yes, I am. Thank
14 you.

15 MS. FLETCHER: Okay, the roll
16 call hearing is concluded.

17 MR. TINPE: Thank you.
