3 CHAIRPERSON MILLER: All right. The
4 next case is Case No. 15-AUD-00018, Tackle Box
5 located at 3245 M Street, N.W., License No.
6 84952, in ANC-2E. Good morning.

7 MS. GEPHARDT: Good afternoon.

8 CHAIRPERSON MILLER: Good morning,
9 still.

10 MS. GEPHARDT: Good morning. Chrissy
11 Gephardt here on behalf of the Office of the
12 Attorney General for the District.

13 CHAIRPERSON MILLER: Okay. Anybody
14 here from Tackle Box? Okay.

15 MEMBER SILVERSTEIN: It doesn't exist.

16 CHAIRPERSON MILLER: Not hearing from
17 anyone, the hearing was called for 10:00 a.m. It
18 is 11:16 a.m. I'll schedule this for a Show
19 Cause Hearing, unless, Ms. Gephardt, you have
20 anything else to adjust?

21 MS. GEPHARDT: I do. I do have
22 something that I would like to bring up with the

1 Board.

2 CHAIRPERSON MILLER: Okay.

3 MS. GEPHARDT: The Government would
4 ask that the Board dismiss this case for the
5 following reason: We have come to learn that
6 this place is closed. This establishment is
7 closed. The notice, the service of the notice
8 was attempted on three different occasions and on
9 those three different occasions, the
10 establishment was closed.

11 Also, on April the 22nd of this year,
12 the licensee applied for or asked for a review of
13 the license to be put in safekeeping and it was
14 granted for six months. So, at this time, the
15 license is in safekeeping and they are not in
16 operation.

17 So we ask that the Board will dismiss
18 this case.

19 CHAIRPERSON MILLER: Do you know for
20 a fact that the license is in safekeeping?

21 MS. GEPHARDT: Right. There is an
22 order.

1 CHAIRPERSON MILLER: Okay.

2 MS. GEPHARDT: Okay, yes.

3 CHAIRPERSON MILLER: Okay. Fine. I
4 just got confirmation also from Legal Counsel.

5 MS. GEPHARDT: Okay.

6 CHAIRPERSON MILLER: Okay. Good. All
7 right. All right.

8 Then I would move that we dismiss the
9 case. Do I have a second?

10 MEMBER SHORT: Second.

11 CHAIRPERSON MILLER: Mr. Short has
12 seconded the motion.

13 All those in favor say aye.

14 ALL: Aye.

15 CHAIRPERSON MILLER: All those
16 opposed? All those abstaining? The motion
17 passes 4-0-0.

18 Thank you.
