3 CHAIRPERSON MILLER: The next case is
4 Case No. 14-CMP-00166, We, the Pizza located at
5 305 Pennsylvania Avenue, S.E., 82062, in ANC-6B.

6 MS. PHILLIPS: Good morning, Board
7 Members. Louise Phillips, Assistant Attorney
8 General for the District of Columbia.

9 MS. WILKEY: Good morning, Board
10 Members. Karina Wilkey representing We, the
11 Pizza.

12 CHAIRPERSON MILLER: Okay. Good
13 morning. Ms. Wilkey, did you receive notice of
14 this hearing?

15 MS. WILKEY: Yes, ma'am.

16 CHAIRPERSON MILLER: Did you read it
17 and understand it?

18 MS. WILKEY: (No audible answer.)

19 CHAIRPERSON MILLER: All right. So
20 there is no issue as to notice with respect to
21 this hearing.

22 MS. WILKEY: No, ma'am.

1 CHAIRPERSON MILLER: Okay. Great.
2 Are there any preliminary matters, Ms. Phillips?

3 MS. PHILLIPS: Yes, Madam Chair. The
4 parties have an Offer in Compromise to present to
5 the Board. It would be a fine of \$2,000 to be
6 paid within 30 days, otherwise they will come and
7 take the license.

8 CHAIRPERSON MILLER: Okay. Ms.
9 Wilkey, did you understand this is an Offer in
10 Compromise for a \$2,000 penalty to be paid within
11 30 days? If it is not paid within 30 days, the
12 license will be suspended until paid.

13 MS. WILKEY: Yes, ma'am.

14 CHAIRPERSON MILLER: Okay. And do you
15 understand that you waive your right to a hearing
16 by entering into this Offer in Compromise?

17 MS. WILKEY: Yes.

18 CHAIRPERSON MILLER: And also you
19 waive your right to appeal?

20 MS. WILKEY: Yes.

21 CHAIRPERSON MILLER: Okay. Any Board
22 questions? All right. Then I would move that

1 the Board approve this Offer in Compromise of
2 \$2,000 to be paid within 30 days. If not paid
3 within 30 days, the license will be suspended
4 until paid. Do I have a second?

5 MEMBER SILVERSTEIN: Second.

6 CHAIRPERSON MILLER: Mr. Silverstein
7 seconded the motion.

8 All those in favor say aye.

9 ALL: Aye.

10 CHAIRPERSON MILLER: All those
11 opposed? All those abstaining? The motion
12 passes 5-0-0.

13 Okay.

14 MS. PHILLIPS: Thank you.

15 CHAIRPERSON MILLER: Thank you.
