3 CHAIRPERSON MILLER: Good morning,
4 everyone. Thank you for your patience. We had a
5 lot more work to do this morning than we usually
6 have and so that's why we are starting a little
7 bit later than usual.

8 Today is July 8, 2015. I want to
9 welcome you to the regularly scheduled meeting of
10 the District of Columbia's Alcoholic Beverage
11 Control Board.

12 My name is Ruthanne Miller. I'm the
13 Chairperson. Joining me to my right is Mr. Nick
14 Alberti and Mr. Hector Rodriguez is now arriving
15 to my right also. And to my left is Mr. Mike
16 Silverstein.

17 MEMBER SILVERSTEIN: Good morning.

18 CHAIRPERSON MILLER: And next to Mr.
19 Silverstein is Mr. James Short. And we have five
20 Members in attendance for business this morning
21 with three constituting a quorum.

22 Copies of today's hearing calendar and

1 agenda are available at the receptionist desk.
2 Please be aware that these proceedings are being
3 recorded by a court reporter. Accordingly, we
4 must ask you to refrain from any disruptive
5 noises or actions in the hearing room.

6 If you have any electronic devices,
7 pagers, cell phones or such, please, make certain
8 that they are turned off to avoid any
9 interruption of the proceedings.

10 When I call your case, please, come
11 forward and take a seat at one of the tables in
12 the front. You will note that there is a piece
13 of paper on each table for you to sign-in. This
14 is to ensure the correct spelling of your name
15 for the record.

16 The Open Meetings Act requires that
17 the public hearing on each case be open to the
18 public. The Board may, consistent with Section
19 405(b) of the Open Meetings Act, enter a closed
20 meeting during or after the public hearing on a
21 case to consult with an attorney to obtain legal
22 advice, discuss settlement agreements or

1 deliberate upon a decision in an adjudication
2 proceeding.

3 Okay. That completes my preliminary
4 remarks and I'm going to start calling the cases
5 on the morning calendar beginning with Case No.
6 15-AUD-00031, Zoo Bar Cafe located at 3000
7 Connecticut Avenue, N.W., License No. 60391, in
8 ANC-3C.

9 MR. RIVERO: Good morning, Board
10 Members. Fernando Rivero for the District of
11 Columbia.

12 CHAIRPERSON MILLER: Good morning, Mr.
13 Rivero.

14 And we have been notified that the
15 licensee is unable to attend the hearing this
16 morning and so we are going to set this for
17 hearing August 5, 2015.

18 COURT REPORTER: Mr. Rivero, please,
19 turn your mike on.

20 MR. RIVERO: Fernando Rivero for the
21 District of Columbia. What was that date?
