CHAIRPERSON MILLER: Okay. The next case on the calendar is Case No. 13-PRO-00063, Bin 1301 Wine Bar located at 1301 U Street, N.W, License No. 91682 in ANC-1B.

Is anybody here for this case? All right. I'm going to pass on this for the moment as no one is here and see if someone shows up by the time we come to the end of the status hearing.

CHAIRPERSON MILLER: I said before we go onto our fact-finding hearings, we passed one case because there were no parties here in that case. That is Case No. 13-PRO-00063, Bin 1301 Wine Bar.

Okay. So there's no one here on this case. We have correspondence in our record that seems to indicate that there is some confusion about the dates. However, they

1 did get -- all the parties did get notice of

10 MEMBER ALBERTI: Yes, Ms. Miller.  
11 I think from the emails I've seen, I think  
12 there is a reasonable -- it's reasonable to  
13 assume that there may be some confusion with  
14 both parties as to what the date is.

15 I recommend -- if you haven't  
16 recommended already, I recommend that we  
17 continue this until next week and we'll notify  
18 the parties today that they are to appear next  
19 week. This way we will just give some  
20 deference to the fact that there may be some  
21 confusion.

22 CHAIRPERSON MILLER: I would agree

1 with you.

2 Any other comments? Okay. I  
3 would move to continue the status hearing for  
4 this case until next week, July 17th. Do I  
5 have a second?

6 MEMBER SILVERSTEIN: Second.

7 CHAIRPERSON MILLER: Okay. All  
8 those in favor say aye.

9 MEMBERS: Aye.

10 CHAIRPERSON MILLER: All those  
11 opposed? Those abstaining? The motion passes  
12 4-0-0.

13 MEMBER ALBERTI: Just one final  
14 comment on that.

15 CHAIRPERSON MILLER: Okay.

16 MEMBER ALBERTI: As of now, I'll  
17 note that the protest date has not changed.

18 CHAIRPERSON MILLER: Correct.

19 MEMBER ALBERTI: With this  
20 continuance the protest date has not changed  
21 and that will be conveyed to the parties along  
22 with notice of their need to appear next week.
