CHAIRPERSON MILLER: Okay. The next case on the calendar is Case Number 13-CMP-00197, Remington's located at 639 Pennsylvania Avenue, S.E., License Number 9238 in ANC 6B.

MS. SCHMIDT: Good morning. Amy Schmidt, Assistant Attorney General on behalf of the District of Columbia.

MR. O'BRIEN: Stephen O'Brien for the License. I'm accompanied by Doug Bogaev spelled B-O-G-A-V-E -- E-V. Excuse me. B-O-G-A-E-V. Who's the Licensee's President.

CHAIRPERSON MILLER: Okay. So, a show cause status hearing. Mr. O'Brien, did your client receive notice of this hearing?

MR. O'BRIEN: He did. He's reviewed it and we waive a formal reading.

CHAIRPERSON MILLER: Okay. And are there any preliminary matters here?

MS. SCHMIDT: Yes. We're only

1 discussing the first case. Correct?

2 CHAIRPERSON MILLER: Correct.

3 MS. SCHMIDT: Yes, I want to make  
4 sure I confirm it.

5 CHAIRPERSON MILLER: Yes.

6 MS. SCHMIDT: Okay. For this  
7 case, then we're asking for a \$4,000 fine,  
8 2,000 for charge 1 and 2,000 for charge 2.

9 CHAIRPERSON MILLER: Okay. We're  
10 discussing Case Number 00197. I only see one  
11 charge there. Yes.

12 MS. SCHMIDT: I'm sorry. I  
13 apologize. I was reading the wrong -- somehow  
14 my files got mixed up with the numbering.  
15 Yes. Okay. In this case, we're asking for a  
16 \$2,000 fine to be payable within seven days.

17 CHAIRPERSON MILLER: Mr. O'Brien?

18 MR. O'BRIEN: Yes. Yes. Yes, and  
19 that is agreeable.

20 CHAIRPERSON MILLER: That is  
21 agreeable to --

22 MR. O'BRIEN: Yes, 2,000 to be

1       paid within seven days.

2                   CHAIRPERSON MILLER: All right.

3       And the Licensee understands that he waives  
4       his right to hearing by entering into this  
5       OIC?

6                   MR. O'BRIEN: He understands that.

7                   CHAIRPERSON MILLER: Okay. Any  
8       questions from Board Members?

9                   Not hearing any, then I move that  
10       we approve this offer in compromise of \$2,000  
11       to be paid within seven days. Do I have a  
12       second?

13                   MEMBER SILVERSTEIN: Second.

14                   CHAIRPERSON MILLER: Mr.  
15       Silverstein has seconded the motion. All  
16       those in favor say aye.

17                   (Ayes.)

18                   CHAIRPERSON MILLER: All those  
19       opposed? All those abstaining? The motion  
20       passes 4-0-0.

21                   (Whereupon, at 10:12 a.m., the  
22       hearing was adjourned.)
