3 BOARD AGENT FLETCHER: Would the  
4 parties in the matter of The Bottom Line  
5 please come forward. The parties in the  
6 matter of The Bottom Line.

7 This is Case No. 14-PRO-00045, CRV  
8 Corporation trading as The Bottom Line, 1716  
9 I Street, N.W. This is Licence No. ABRA-  
10 000755. This is a retailer CT, substantial  
11 change (change of hours.)

12 The protest issues are adverse  
13 impact on peace, order and quiet and parking.

14 My name is LaVerne Fletcher and  
15 I'm conducting the Roll Call Hearing as the  
16 Board's agent pursuant to D.C. Official Code  
17 1601.2. Are you the applicant?

18 MR. MOSBRUCKER: Yes.

19 BOARD AGENT FLETCHER: And you  
20 can have a seat at that table. And if you  
21 would state your name and spell it for the  
22 record please.

1                   MR. MOSBRUCKER:    My name is  
2 Eugene Mosbrucker E-u-g-e-n-e first name and  
3 last name Mosbrucker M-o-s-b-r-u-c-k-e-r.

4                   BOARD AGENT FLETCHER:    Would you  
5 just spell your last name one more time?

6                   MR. MOSBRUCKER:    Yes.  M as in  
7 Mary, O, S as in Sam, B as in boy RUCKER.

8                   BOARD AGENT FLETCHER:    Thank you  
9 very much.  And you're the applicant?

10                  MR. MOSBRUCKER:    Yes.  I'm the  
11 current general manager.

12                  BOARD AGENT FLETCHER:    And is  
13 there any particular reason why the owner is  
14 not present today?

15                  MS. MOSBRUCKER:    He is not in  
16 town.

17                  BOARD AGENT FLETCHER:    And have  
18 you had any communication with ANC 2B?

19                  MR. MOSBRRUCKER:    Yes.  We went  
20 to the meeting last week and spoke in front of  
21 the Commission and we actually got a letter  
22 from them saying that apparently I guess we

1 filled it out for summer garden hours which we  
2 do not need and they said they were in support  
3 of us as long as we got that changed.

4 I had talked last week with a  
5 member of the licensing department and I'm  
6 waiting to hear back from Mr. Gordie about how  
7 to change the application.

8 BOARD AGENT FLETCHER: Okay.

9 MR. MOSBRUCKER: But we have no  
10 summer garden, have no intention of a summer  
11 garden, no space for a summer garden. We just  
12 want to be able to open up earlier for brunch  
13 on the weekends to try and make up for the  
14 loss of business at nights that we don't have  
15 any more.

16 BOARD AGENT FLETCHER: So you're  
17 just going to be amending your application?

18 MR. MOSBRUCKER: Correct.

19 BOARD AGENT FLETCHER: And based  
20 on what you're explaining, once you do that,  
21 ANC 2B will withdraw its protest? That's your  
22 understanding?

1 MR. MOSBRUCKER: Correct.

2 BOARD AGENT FLETCHER: Okay.

3 Because ANC 2B is not present today, I'm going  
4 to dismiss the protest called by ANC 2B. You  
5 all may still resolve the matter in that way  
6 and once they submit a letter to the Board  
7 withdrawing the protest the Board will issue  
8 an order accepting the withdrawal of the  
9 protest.

10 For the purpose of the Roll Call  
11 Hearing ANC 2B is dismissed as a protestant.

12 Did you put your contact  
13 information on that sheet?

14 MR. MOSBRUCKER: Yes, I just  
15 filled it out.

16 BOARD AGENT FLETCHER: Okay.  
17 Thank you very much. The Roll Call Hearing is  
18 concluded.
