17 And we expect the ownership group

19 vote by the ANC, which we may call a special  
20 meeting to conduct. We find that this is  
21 resolved.

2                       MR. FONSECA: No.

3                       CHAIRPERSON MILLER: Okay. I'm  
4 still going to set your Protest Hearing. And  
5 it'll come off the calendar once the agreement

9 Hearing set for September 25th, 2013, at 1:30  
10 p.m.

11                      And for the record, I just need to  
12 alert you that you need to submit this protest  
13 information form at the desk before the  
14 hearing, seven days in advance, to ABRA and  
15 parties. And if you don't, your protest  
16 application would be dismissed.

19                      Sounds good, so hopefully you won't  
20 need any of that information. Okay, thank  
21 you.
