MS. FLETCHER: Would the parties in the matter of Brick Lane Restaurant please come forward. The parties in the matter of Brick Lane.

This is Case No. 15-PRO-00070, Brick Lane, DC, Inc., trading as Brick Lane Restaurant, 1636 17th Street, N.W., License No. ABRA-098427. This is a new application. The protest issues are adverse impact on peace, order, and quiet.

My name is La Verne Fletcher. I'm conducting the roll call hearing as the Board's agent, pursuant to D.C. Official Code 1601.2.

Introductions, beginning with the Applicant.

MR. IKHIAR: Hi. I'm Elalami Ikhlar.

MS. FLETCHER: And would you spell that for the record, please?

MR. IKHIAR: I-K-H-I-A-R.

MS. FLETCHER: I'm sorry?

MR. IKHIAR: I-K-H-I-A-R.

MS. FLETCHER: And is that the first or

3 MS. FLETCHER: And what's the last
4 name?

5 MR. IKHIAR: Elalami. E-L-A-L-A-M-I.

6 MS. FLETCHER: Thank you very much. And
7 on behalf of ANC 2B?

8 MS. MANN: I'm Nicole Mann. M-A-N-N.

9 MS. FLETCHER: Thank you, Ms. Mann.
10 Nicole is spelled N-I-C-O-L-E?

11 MS. MANN: Yes.

12 MS. FLETCHER: Thank you. ANC 2B does
13 have standing as a protestant. We need to
14 schedule a date for mediation, a status hearing,
15 and a protest hearing. I'll give you the date for
16 the status and protest hearing first.

17 The date for the status hearing is
18 September 16th at 9:30 a.m.

19 MR. IKHIAR: 9:30?

20 MS. FLETCHER: Yes. And the date for
21 the protest hearing is October 14 at 1:30 p.m.
22 You'll receive a written notice also. We need to

1 set a date for mediation. I'll give you the next
2 date that's available.

3 The next available date for mediation
4 is August 13 at 9:00, 10:00, or 11:00. That is
5 next Thursday.

6 MS. MANN: 9:00? Is that alright? 9:00?

7 MR. IKHIAR: 9:00 or 10:00.

8 MS. FLETCHER: 9:00 or 10:00?

9 MS. MANN: 9:00's better.

10 MS. FLETCHER: 9:00 is good?

11 MS. MANN: Yes.

12 MS. FLETCHER: Okay. Then mediation is
13 set for August 13th at 9:00 o'clock.

14 MR. IKHIAR: Same room?

15 MS. FLETCHER: Yes. Just check in with
16 the reception desk, and I'll come out, and we'll
17 come in to, most likely, this room.

18 MS. MANN: Okay.

19 MS. FLETCHER: So, did you put your ---
20 oh, you're filling out the contact information
21 sheet right now, aren't you?

22 MR. IKHIAR: I'm just putting the dates

1 on this paper.

2 MS. FLETCHER: Yes. Put your daytime
3 phone number and email address on the contact
4 sheet.

5 MR. IKHIAR: Oh, on this one right
6 here?

7 MS. FLETCHER: Yes.

8 MR. IKHIAR: Okay. Can I have another
