CHAIRPERSON MILLER: The next case is Case No. 15-CMP-00063, Second State, that is located at 1831 M Street, N.W., License No. 84184, in ANC-2B.

Second State?

MR. WHELAN: Yes.

CHAIRPERSON MILLER: Okay. When you are ready, would you sign-in and introduce yourselves for the record?

MR. WHELAN: Good morning. Stephen Whelan on behalf of Second State.

MS. GEPHARDT: Good morning. I'm Chrissy Gephardt on behalf of the Office of the Attorney General.

20 license would be suspended immediately.

21 CHAIRPERSON MILLER: Okay. Mr.
22 Whelan, do you, on behalf of your client, agree

1 to the Offer in Compromise of \$350 to be paid
2 within 30 days?

3 MR. WHELAN: Yes, we do.

4 CHAIRPERSON MILLER: Okay. Any
5 questions by Board Members? Not hearing any,
6 then I move to approve the Offer in Compromise of
7 \$350 to be paid within 30 days. If not paid
8 within 30 days, the license will be suspended.
9 Do I have a second?

10 MEMBER SHORT: Second.

11 CHAIRPERSON MILLER: Mr. Short has
12 seconded the motion.

13 All those in favor say aye.

14 ALL: Aye.

15 CHAIRPERSON MILLER: All those
16 opposed? All those abstaining? The motion
17 passes 6-0-0. Okay.
