3 CHAIRPERSON MILLER: Okay, next case is  
4 Case No. 15-AUD-00012, Buck's Fishing and Camping,  
5 located at 5031 Connecticut Avenue, Northwest, License  
6 No. 60769 in ANC 3F.

7 MR. RIVERO: Good morning, Board Members.  
8 Fernando Rivero for the District of Columbia, standing  
9 in for Christine Gephardt.

10 CHAIRPERSON MILLER: Good morning.

11 MR. KLINE: Good morning. Andrew Kline on  
12 behalf of the licensee.

13 MR. ALEFANTIS: James Alefantis,  
14 proprietor.

15 CHAIRPERSON MILLER: Okay, good morning.  
16 Mr. Kline, did your client receive notice of this  
17 hearing?

18 MR. KLINE: Yes, received notice of the  
19 hearing, read and understood it and waive any required  
20 formal reading.

21 CHAIRPERSON MILLER: Okay, are there any  
22 preliminary matters?

1 MR. RIVERO: Yes, the parties have an  
2 offer in compromise to present to the Board at this  
3 time.

4 CHAIRPERSON MILLER: Okay.

5 MR. RIVERO: That offer consists of a fine  
6 of \$500, payable within 30 days, and if not paid  
7 within 30 days, the license will be suspended until  
8 payment is received.

9 CHAIRPERSON MILLER: Okay, Mr. Kline, is  
10 your client agreeable to an offer in compromise,  
11 consisting of a fine of \$500 to be paid within 30  
12 days, if not paid within 30 days, then the license  
13 will be suspended until payment is received?

14 MR. KLINE: Yes, the offer is acceptable  
15 and licensee understands that if it's accepted by the  
16 Board, that the licensee waives its right to hearing  
17 and its right to appeal.

18 CHAIRPERSON MILLER: Okay, any questions  
19 by Board members? Okay, then I move that we approve  
20 this offer in compromise of a fine of \$500 to be paid  
21 within 30 days, if not paid within 30 days, license  
22 will be suspended until the fine is paid.

1 MEMBER SILVERSTEIN: Second.

2 CHAIRPERSON MILLER: Mr. Silverstein  
3 seconded the motion. All those in favor, say aye.

4 (Chorus of ayes.)

5 CHAIRPERSON MILLER: All those opposed?
