BOARD MEDIATOR FLETCHER: Would the parties in the matter of Marrakech Restaurant please come forward. The parties in the matter of Marrakech Restaurant. This is Case No. 15-PRO-00074, La Kazbah, LLC, trading as Marrakech Restaurant, 2147 P Street, NW. License No. ABRA-090204. This is a Retailer Class CT Substantial Change. Change of hours of entertainment endorsement.

The protest issues are adverse impact on peace, order and quiet.

My name is LaVerne Fletcher, I'm conducting the Roll Call Hearing as the Board's agent pursuant to D.C. Office Code 1601.2. Is anyone present on behalf of the restaurant?

10 meeting about a month ago when there was push-  
11 back from the ANC that we were going to protest.  
12 The applicant said that he would rescind the  
13 application because, according to him at that  
14 meeting, it was not that big of a deal.

15 When I saw the Roll Call Hearing being  
16 published on Thursday I reached out to the  
17 applicant and when I reached out to the applicant  
18 he said he would cancel it.

19 I contacted a staff member Friday  
20 around noon and it wasn't cancelled so I figured  
21 I might as well show up.

22 BOARD MEDIATOR FLETCHER: Well, yes.

1 Thank you for doing that. The ANC-2B of course  
2 has standing as a protestant. The application is  
3 dismissed because the applicant failed to appear  
4 today.

5 MR. WARWICK: Thank you, ma'am.

6 BOARD MEDIATOR FLETCHER: So the  
7 application is dismissed and an order will go out  
8 from the Board to the applicant with a copy to  
9 the ANC regarding the dismissal of the  
10 application. And the applicant will have 10  
11 days to seek reinstatement of the application;  
12 the ANC gets a chance to respond to the motion if  
13 it's filed. And so the application is dismissed.

14 MR. WARWICK: Thank you for your  
15 time.
