3 MS. FLETCHER: Would the parties
4 in the matter of Doner Bistro please come
5 forward? The parties in the matter of Doner
6 Bistro?

7 This is Case #13-PRO-00114, DB
8 Adams Morgan, LLC, trading as Doner Bistro,
9 1654 Columbia Road, NW, License #ABRA-089877.
10 This is a Retailer DR, a Substantial Change
11 for an Entertainment Endorsement. The protest
12 issues are adverse impact on peace, order and
13 quiet.

14 My name is LaVerne Fletcher, and
15 I'll be conducting the Roll Call Hearing as
16 the Board's Agent pursuant to DC Official Code
17 1601.2.

18 Introductions beginning with the
19 Licensee?

20 MR. WINKEL: Yes. My name is Timo
21 Wankel. And I'm the President and founder of
22 the DB Adams Morgan, LLC.

1 MS. FLETCHER: Thank you. And
2 would you spell your name for the court
3 reporter, please?

4 MR. WINKEL: T-I-M-O, and last
5 name Winkel -- W-I-N-K-E-L.

6 MS. FLETCHER: W-I-N-K-E-N?

7 MR. WINKEL: E-L.

8 MS. FLETCHER: Thank you, Mr.
9 Winkel.

10 I'm aware that Andrew Kline is
11 your attorney in this matter, is that correct?

12 MR. WINKEL: Yes, ma'am.

13 MS. FLETCHER: Okay. But would
14 you still put your contact information on that
15 sheet?

16 MR. WINKEL: Okay.

17 MS. FLETCHER: Thank you very
18 much.

19 And just for the record, Mr. Kline
20 did call me this morning to explain why he
21 wouldn't be present.

22 And on behalf of ANC 1C?

1 MR. GUTHRIE: Ted Guthrie -- T-E-D
2 G-U-T-H-R-I-E.

3 MS. FLETCHER: Thank you, Mr.
4 Guthrie.

5 And Mr. Guthrie, did you fill in
6 the contact information?

7 MR. GUTHRIE: Yes.

8 MS. FLETCHER: ANC 1C does have
9 standing as a protestant.

10 We need to set a date for
11 mediation, a status hearing and a protest
12 hearing.

13 The date for the status hearing is
14 set for October the 2nd -- October 2nd for the
15 status hearing at 9:30 a.m.

16 The date for the protest hearing
17 is December the 4th -- December the 4th at
18 1:30 p.m.

19 We need to set a date for
20 mediation to occur prior to October 2nd. And
21 I'll give you some dates that are available.

22 Wednesday, October 25 is

1 available.

2 MR. GUTHRIE: The current status
3 in the case is that we have a preliminary
4 agreement that we're getting signed today by
5 the Applicant, and tomorrow it's going to be
6 approved presumably at the ANC meeting. And
7 I have no idea what Mr. Simpson's schedule is,
8 and he'd normally be the one who's on this
9 case.

10 MS. FLETCHER: Yes.

11 MR. GUTHRIE: So assign us
12 something and it's fine because it's going to
13 go away, I think.

14 MR. WINKEL: Yes.

15 MS. FLETCHER: Yes, I'll put the
16 date on for the record. But I've made a note.
17 So then we'll just make it Wednesday,
18 September 25 just for the sake of having
19 something on the record.

20 And what about 10:00 o'clock? Ten
21 o'clock?

22 Well, that's perfect. Thank you.

1 Thanks for coming.

2 MR. GUTHRIE: Thanks so much.

3 MR. WINKEL: Thank you.

4 MS. FLETCHER: The Roll Call
5 Hearing is concluded.
