3 CHAIRPERSON MILLER: Next is Case No.
4 15-CMP-00217, Brentwood Liquors located at 1319
5 Rhode Island Avenue, N.E., License No. 60622, in
6 ANC-5C. Good morning.

7 MR. YOO: Yes. Good morning.

8 MS. SCHMIDT: Good morning. Amy
9 Schmidt, Assistant Attorney General on behalf of
10 the District of Columbia.

11 CHAIRPERSON MILLER: And, sir, would
12 you introduce yourself?

13 MR. YOO: Pardon?

14 CHAIRPERSON MILLER: Would you
15 introduce yourself?

16 MR. YOO: Yes. My name is Ji Yoo. I
17 am --

18 CHAIRPERSON MILLER: You can sit down.

19 MR. YOO: -- the owner of Brentwood
20 Liquor and Grocery, the location on the new
21 development in city and the location I have to
22 move within a few months, short lease maybe

1 yearly.

2 CHAIRPERSON MILLER: Okay. Wait.

3 MR. YOO: I don't know the time.

4 CHAIRPERSON MILLER: Let me stop you.

5 This is just a quick status, but you -- are you
6 the owner?

7 MR. YOO: Yes, ma'am, I'm the owner.

8 CHAIRPERSON MILLER: Okay. So this
9 hearing, I don't know if you were in the room
10 when I gave out general instructions, which is
11 just about to see if there are any preliminary
12 matters. It's not the hearing on the merits.
13 Okay. It's just did you come to -- do you have
14 an agreement you want to present to us or do you
15 have any questions about the hearing.

16 Ms. Schmidt, is there --

17 MS. SCHMIDT: No, there is no
18 agreement.

19 CHAIRPERSON MILLER: -- any
20 preliminary -- okay. Do you have any questions
21 then about your hearing coming up in October 14th?

22 MR. YOO: Well, yeah. I'm considering

1 about the -- think about the reconsideration for
2 my case. You are undecided, but they give me a
3 \$2,000 fine or I got -- I thought I come here.
4 We do some considering and reduce the fine.

5 MS. SCHMIDT: That's the --

6 MR. YOO: Because --

7 CHAIRPERSON MILLER: Okay. We are not
8 doing that hearing today. That hearing on what
9 happened and if you are responsible for whatever
10 is October 14. This is just scheduling it.

11 MR. YOO: Okay.

12 MS. SCHMIDT: You need to speak to Ms.
13 Phillips about it in the corner over there.

14 CHAIRPERSON MILLER: Okay. Thank you.

15 MS. SCHMIDT: For the record, I'm just
16 pointing out that he can speak to Ms. Phillips
17 about any other offer.

18 CHAIRPERSON MILLER: Good. I also
19 want to ask you, what is your native language?
20 Your first language? Is it Korean?

21 MR. YOO: Yes, I'm Korean.

22 CHAIRPERSON MILLER: Okay. Would you

1 like the assistance at the hearing of an
2 Interpreter?

3 MR. YOO: Yes.

4 CHAIRPERSON MILLER: Okay. So we will
5 note that for our records. And do you have other
6 questions? I believe that Ms. Phillips -- I
7 mean, Ms. Schmidt gave you the attorney on the
8 case for the Government is Ms. Phillips. And he
9 can call her as well.

10 MS. SCHMIDT: Yes.

11 CHAIRPERSON MILLER: So we will have
