3 MS. FLETCHER: So I'm calling Case No.
4 20-PRO-00035, Yegna Restaurant and Lounge, Inc,
5 t/a Asefu's Palace, 1920 9th NW, License No.
6 ABRA-112748. This is a Retailer Class CT license
7 renewal. The protest issues are adverse impact
8 on peace, order, and quiet, residential parking,
9 and vehicular and pedestrian safety, and real
10 property values.

11 Ms. Schlom, would you please spell
12 your name for the record?

13 MR. SCHLOM: Absolutely. First name
14 is Evan, E-V-A-N, last name is S-C-H-L-O-M.

15 MS. FLETCHER: Thank you very much.
16 And Mr. Schlom, you're representing the group of
17 eight?

18 MR. SCHLOM: That is correct.

19 MS. FLETCHER: Thank you. Are there
20 any other individuals present within your group
21 today?

22 MR. SCHLOM: I am the one member, no.

23 MS. FLETCHER: Thank you very much.
24 So I'm granting conditional standing to the group
25 of eight. And four more need to appear at the

1 upcoming status hearing -- four more that are not
2 -- four additional people need to appear.

3 MR. SCHLOM: Understood, thank you.

4 MS. FLETCHER: So Mr. Schlom, we allow
5 a ten minute grace period for parties to arrive.
6 And so I'm going to check out for a minute and
7 I'll come back in ten minutes to see if the
8 Applicant has arrived.

9 MR. SCHLOM: All right, thank you.

10 MS. FLETCHER: Okay, see you shortly.

11 (Whereupon, the above-entitled matter
12 went off the record at 11:32 a.m. and resumed at
13 11:40 a.m.)

14 MS. FLETCHER: Mr. Schlom?

15 MR. SCHLOM: Yes. It is 11:30. The
16 Applicant has not yet appeared. I'm going to
17 dismiss the license renewal application. The
18 licensee will receive a board order dismissing
19 the application and you'll receive a copy of the
20 order. If they seek reinstatement, I'll get back
21 with you to set up a date for mediation, the
22 status hearing, and the protest hearing.

23 MR. SCHLOM: Understood. Thank you
24 very much.

25 MS. FLETCHER: Thank you very much.

1 And thank you for coming.

2 MR. SCHLOM: Have a good day. Thank
3 you.

4 MS. FLETCHER: Okay, you too. The
5 roll call hearing is concluded.
