3 CHAIRPERSON MILLER: The next case
4 on our calendar is another Show Cause (Status)
5 Hearing, Case No. 12-CMP-00291, Napoleon
6 located at 1847 Columbia Road, N.W., License
7 No. 75836, in ANC-1C.

8 MS. GEPHARDT: Good morning.
9 Chrissy Gephardt on behalf of the Office of
10 the Attorney General.

11 CHAIRPERSON MILLER: Good morning.

12 MR. MOLLOY: Brian Molloy from
13 Mallios & O'Brien on behalf of the licensee.
14 Good morning.

15 MR. POPAL: And Omar Popal.

16 CHAIRPERSON MILLER: All right.
17 This is a Show Cause (Status) Hearing. Mr.
18 Molloy, did your client receive notice of this
19 hearing?

20 MR. MOLLOY: Yes.

21 CHAIRPERSON MILLER: Did he read
22 it and understand it?

1 MR. MOLLOY: Yes.

2 CHAIRPERSON MILLER: Okay. That
3 notice then will become part of the record.

4 (Whereupon, the document was
5 marked as Exhibit 1 for
6 identification.)

7 CHAIRPERSON MILLER: Ms. Gephardt,
8 are there any preliminary matters?

9 MS. GEPHARDT: Yes, there is a
10 preliminary matter. In this case, the parties
11 have come to an agreement on an offer in
12 compromise and that offer would be a \$500 fine
13 and that would be payable within 30 days.

14 CHAIRPERSON MILLER: Okay. Mr.
15 Molloy, is your client agreeable to the \$500
16 fine payable within 30 days?

17 MR. MOLLOY: He is.

18 CHAIRPERSON MILLER: And
19 understands that he waives his right to a
20 hearing?

21 MR. MOLLOY: Yes.

22 CHAIRPERSON MILLER: Okay. Any

1 questions by Board Members? I then move to
2 approve this offer in compromise of \$500 to be
3 paid within 30 days.

4 MEMBER SILVERSTEIN: Second.

5 CHAIRPERSON MILLER: Mr.

6 Silverstein has seconded the motion.

7 All those in favor say aye.

8 ALL: Aye.

9 CHAIRPERSON MILLER: All those
10 opposed? All those abstaining? The motion
11 passes to approve the offer in compromise of
12 a \$500 fine to be paid within 30 days.

13 Okay. While we are waiting for me
14 to sign the order, is this your last case now
15 of the morning?

16 MR. MOLLOY: Yes.

17 CHAIRPERSON MILLER: Okay. Let me
18 finish this case and then I'll call that case.

19 All right. So that concludes this
20 Show Cause (Status) on Napoleon.
