3 CHAIRPERSON MILLER: Okay. Good
4 morning, ladies and gentlemen. I'd like to
5 welcome you to the regularly scheduled meeting
6 of the District of Columbia Alcoholic Beverage
7 Control Board. Today is October 23rd, 2013.

8 My name is Ruthanne Miller. I'm
9 the Chairperson. Joining me today to my far
10 right is Mr. Donald Brooks, to my immediate
11 right is Mr. Nick Alberti, and to my immediate
12 left is Mr. Mike Silverstein. The Board has
13 four members in attendance for the conduct of
14 business this morning with three constituting
15 a quorum.

16 Copies of today's hearing calendar
17 and agenda are available at the receptionist's
18 desk.

19 Please be aware that these
20 proceedings are being recorded by a court
21 reporter. Accordingly, we must ask you to
22 refrain from any disruptive noises or actions

1 in the hearing room. If you have any
2 electronic devices, pagers, cell phones or
3 such, please make certain they're turned off
4 to avoid any interruption of the proceedings.

5 When I call your case, please come
6 forward and take a seat at the table. You
7 will note that there is a piece of paper on
8 each table for you to sign in. This is to
9 ensure the correct spelling of your name for
10 the record.

11 The Open Meetings Act requires
12 that the public hearing on each case be open
13 to the public. The Board, may consistent with
14 Section 405(b) of the Open Meetings Act, enter
15 a closed meeting during or after the public
16 hearing on a case to consult with an attorney
17 to obtain legal advice, discuss settlement
18 agreements or deliberate upon a decision in an
19 adjudication proceeding.

20 Okay. We'll now turn to this
21 morning's calendar. And the first case on the
22 calendar is Bolt Burger, Case No. 13-PRO-

2 Massachusetts Avenue, N.W. It's License No.
3 92541.

4 Good morning.

5 MR. KLINE: Good morning. Andrew
6 Kline for the Applicant.

7 CHAIRPERSON MILLER: Okay.

8 MR. KLINE: You will note the
9 Protestants are not here and that is because
10 we have reached a settlement agreement. A
11 copy was transmitted to Ms. Fletcher

13 slight amendment to the application. It will
14 be filed in the next day or two, which should
15 resolves this matter, pending of course the
16 Board's approval.
