1 P R O C E E D I N G S

2 CHAIRPERSON FLETCHER: Would the parties
3 in the matter of Tasty Burger please come
4 forward? The parties in the matter of Tasty
5 Burger. This is case #15-PRO-000107. Excuse me.
6 Uh, this is case number -- excuse me in the back,
7 we can't hear up here. Thank you. This is case
8 #15-PRO-000107, Tasty Burger PC1, LLC, trading as
9 Tasty Burger, 2108 8th Street Northwest, License
10 #100284. This is a Retailer CR, New Application.
11 The protest issues are adverse impact on peace,
12 order and quiet. My name is Laverne Fletcher and
13 I am conducting the roll call hearing as the
14 Board's Agent pursuant to D.C. Official Code
15 1601.2. Introductions beginning with the
16 applicant please.

17 SPEAKER: Good morning. Stephen Whelan
18 from the Veritas Law Firm on behalf of Tasty
19 Burger, DC1 LLC, trading as Tasty Burger, that's
20 Stephen, S-T-E-P-H-E-N, Whelan, W-H-E-L-A-N.

21 CHAIRPERSON FLETCHER: And Mr. Whelan,
22 would you spell the name of your law firm? I

1 didn't get you to do that before.

2 MR. WHELAN:/ Sure. Veritas, V-E-R-I-T-A-
3 S Law Firm.

4 CHAIRPERSON FLETCHER: And, just for the
5 record, Mr. Whelan you are representing the
6 Applicant in the last two cases?

7 MR. WHELAN: That's correct.

8 CHAIRPERSON FLETCHER: So for Bar Pilar
9 and for MMA you also represented the applicant
10 for Veritas Law Firm?

11 MR. WHELAN: Correct. CHAIRPERSON
12 FLETCHER: Okay, thank you. And present on
13 behalf of ANC 1B?

14 SPEAKER: Ah, yes. Commissioner John
15 Green, no "E" at the end.

16 CHAIRPERSON FLETCHER: No "E" at the end.
17 Thank you, Mr. Green. ANC 1B has standing as a
18 protestant. We need to set a date for mediation,
19 a status hearing and a protest hearing. The date
20 for the status hearing is January 6, 2016, at
21 9:30 a.m. The date for the protest hearing is
22 January 27, 2016, at 1:30 p.m.

1 MR. GREEN: It's the 27th?

2 CHAIRPERSON FLETCHER: Yes, January 27th
3 at 1:30 p.m.

4 MR. GREEN: Okay.

5 CHAIRPERSON FLETCHER: The next available
6 date for mediation is actually the week after
7 Christmas, so I'll just give you the dates that
8 are available. Tuesday, December 29, if that's
9 good for anybody? And that would be at 9:00,
10 10:00 or 11:00 on December 29.

11 MR. WHELAN: Is it possible to push it
12 into January?

13 CHAIRPERSON FLETCHER: Yes. The status
14 hearing is on January 6th, so we could do it on
15 January 5 at 9:00, 10:00 or 11:00, or January 4,
16 which is Monday, in the afternoon, or we can do
17 the mediation after the status hearing if that
18 would be a more convenient -- generally it is
19 done before the status meeting but we can do it
20 after if that's just not a good time.

21 MR. WHELAN: January 4th or 5th are fine.

22 CHAIRPERSON FLETCHER: Mr. Green do you

1 have a preference for January 4 or 5? If it's on
2 the 4th it will be at 1:00 in the afternoon.

3 MR. GREEN: On the 4th is fine.

4 CHAIRPERSON FLETCHER: Is that good?

5 MR. GREEN: Yeah.

6 CHAIRPERSON FLETCHER: So the mediation
7 is set for Monday, January 4th, at 1:00 in the
8 afternoon. Any questions at all? No? Okay.
9 The Roll Call Hearing is concluded. Thanks for
10 coming.
