3 BOARD AGENT FLETCHER: The first
4 case is Andy's Carryout. If you would just
5 step forward for a second please. Thank you.

6 MR. NO: May I have a seat
7 please?

8 BOARD AGENT FLETCHER: Yes. And
9 this is Case No. 14-PRO-00094, No Jun Choon
10 and Myong A, t/a Andy's Carryout, 209 New York
11 Avenue, N.W., License No. ABRA-021721 Retailer
12 Class B license Renewal.

13 Would you please state your name
14 and spell it for the record. You can just
15 talk right into that microphone, if you would
16 just state your name and spell it, that would
17 be good.

18 MR. NO: Okay. My name is Jun
19 Choon No. I'm calling for--

20 BOARD AGENT FLETCHER: And would
21 you spell it please?

22 MR NO: Yes. J-u-n, my first name

1 is Jun. Middle name C-h-o-o-n last name N-o.

2 BOARD AGENT FLETCHER: I'm sorry,
3 what's the last name again?

4 MR. NO: N-o. Just N-o.

5 BOARD AGENT FLETCHER: Okay. And
6 Mr. No, my understanding is that the ANC has
7 withdrawn its protest, ANC 6E.

8 MR. NO: Yes.

9 BOARD AGENT FLETCHER: Okay. I

11 the room and so I called your case first to
12 let you know that we're aware now that the ANC
13 has withdrawn its protest against your
14 application.

15 MR. NO: Yes.

16 BOARD AGENT FLETCHER: I'm just
17 stating that for the record so this hearing
18 will not be held. The ANC will not be
19 dismissed because they're not here. They have
20 informed us just a short time ago that they
21 have withdrawn the protest and so you may
22 proceed through the license renewal process.

1 MR. NO: Okay.

2 BOARD AGENT FLETCHER: I spoke
3 with you this morning on the telephone. At the
4 time that I spoke with you, I was not aware
5 that the ANC had withdrawn its protest. I did
6 not know that at the time. So someone just
7 informed me, just before I came into the room
8 that they have withdrawn the protest because
9 you all have resolved this matter.

10 MR. NO: Thank you.

11 BOARD AGENT FLETCHER: And so
12 there is nothing that you need to do. Thank
13 you for coming. If I had known that ahead of
14 time I would have told you not to come down.
15 Okay?

16 MR. NO: Okay. Thank you.

17 BOARD AGENT FLETCHER: So the
18 roll call hearing is concluded. Thank you.
