3 BOARD AGENT FLETCHER: Would the  
4 parties in the matter of D & B Carryout please  
5 come forward. The parties in the matter of D  
6 & B Carryout. This is Case No. 14-PRO-00091,  
7 Hwang and Hyun O. Kim, t/a D & B Carryout.  
8 Would the parties in the matter of D & B  
9 Carryout please come forward.

10 MR. HOLLAND: Yes ma'am. I'm here  
11 for Mr. Kim--

12 BOARD AGENT FLETCHER: Okay. But  
13 you can't speak from the back. You have to  
14 come up to the table.

15 MR. HOLLAND: I'm sorry.

16 BOARD AGENT FLETCHER: And state  
17 your name.

18 MR. HOLLAND: My name is Paul  
19 Holland for Mr. Kim.

20 BOARD AGENT FLETCHER: That's  
21 fine. Could you spell your name for the record  
22 please.

1 MR. HOLLAND: Paul P-a-u-l and  
2 last name Holland H-o-l-l-a-n-d.

3 BOARD AGENT FLETCHER: I  
4 understand, Mr. Holland. You're saying that  
5 Mr. Kim is on his way?

6 MR. HOLLAND: He's on his way,  
7 right.

8 BOARD AGENT FLETCHER: What does  
9 that mean? Is he downstairs?

10 MR. HOLLAND: He's downstairs  
11 trying to find somewhere to park.

12 BOARD AGENT FLETCHER: Okay.  
13 Would you just please stay there for me?

14 MR. HOLLAND: Yes ma'am.

15 BOARD AGENT FLETCHER: Thank you.  
16 The address is 3412 Georgia Avenue N.W.,  
17 License No. ABRA-026649. This is a Retailer  
18 Class B License Renewal. Is there anyone here  
19 present from the protestant? Is Keith Dokho  
20 present? Keith D-o-k-h-o. Is he present?  
21 Are there any individuals present from the  
22 protestant group in the matter of D & B

1 Carryout?

2 Mr. Holland, I'm going to ask you  
3 to take a seat behind you. I'm going to give  
4 Mr. Kim an opportunity to appear.

5 MR. HOLLAND: Okay.

6 BOARD AGENT FLETCHER: I'll  
7 recall the case in about five minutes.

8 MR. HOLLAND: Yes ma'am.

9 BOARD AGENT FLETCHER: Okay. So  
10 I'm going to close out the case of D & B  
11 Carryout for the moment and reopen it  
12 momentarily.

13 (A BRIEF RECESS WAS TAKEN)

14 BOARD AGENT FLETCHER: Are the  
15 protestants present in the matter of D & B  
16 Carryout?

17 MR. KIM: Yes.

18 BOARD AGENT FLETCHER: Okay.  
19 Would you please step forward, sir. And would  
20 you please state your name for the record and  
21 spell it.

22 MR. KIM: Name is Hwang Kim.

1 BOARD AGENT FLETCHER: And how do  
2 you spell that please?

3 MR. KIM: H-w-a-n-g and last name  
4 is K-i-m, Kim.

5 BOARD AGENT FLETCHER: Thank you,  
6 Mr. Kim.

7 MR. KIM: You're welcome.

8 BOARD AGENT FLETCHER: Would you  
9 please put your contact information on that  
10 sheet? There's a sheet there to put your  
11 name, telephone number and email address.

12 The protestants in this matter are  
13 now present. The protest is dismissed.

14 MR. HOLLAND: Are you Ms.  
15 Fletcher?

16 BOARD AGENT FLETCHER: Yes.

17 MR. HOLLAND: Okay.

18 BOARD AGENT FLETCHER: Mr. Kim,  
19 the protestants in this matter are not present  
20 and so the protest is dismissed. The  
21 protestants will receive an order, you'll  
22 receive a copy of the order dismissing the

1 protestants for failure to appear.

2 The protestants will have 10 days  
3 to seek reinstatement of the protest for good  
4 cause and you will be kept informed. But as of  
5 today there are no protestants in this matter  
6 but you need to wait to receive the Board  
7 Order dismissing the protestants and they will  
8 have 10 days to seek reinstatement of the  
9 protest.

10 MR. KIM: Thank you.

11 BOARD AGENT FLETCHER: Okay.

12 Thank you. The Roll Call Hearing is  
13 concluded. Thank you.

14 MR. HOLLAND: Thanks a lot, Ms.

15 Fletcher.

16 BOARD AGENT FLETCHER: Okay.
