3 CHAIRPERSON MILLER: Okay. Okay.

4 Let's go back to the one I skipped right
5 before that. It's Case No. 12-CMP-00708,
6 Irish Whiskey located at 1207 19th Street,
7 N.W., License No. 87685.

8 MS. PHILLIPS: Good morning, Madam
9 Chair, Louise Phillips, Assistant Attorney
10 General, for the District of Columbia.

11 CHAIRPERSON MILLER: Okay.

12 MR. KLINE: Good morning, Andrew
13 Kline on behalf of the licensee.

14 MR. HARPER: Good morning, Sam
15 Harper.

16 CHAIRPERSON MILLER: Okay. Good
17 morning. All right.

18 Mr. Kline, did your client receive
19 notice of this hearing?

20 MR. KLINE: Yes, received it, read
21 it, understood it and waive any required
22 formal reading.

1 CHAIRPERSON MILLER: Okay. Good.
2 Ms. Phillips, are there any preliminary
3 matters?

4 MS. PHILLIPS: Yes, Madam Chair.
5 The parties have reached an agreement, which
6 we hope the Board will approve, for a fine of
7 \$350 to be paid within 30 days, but I think
8 they are paying it today.

9 CHAIRPERSON MILLER: Okay.

10 MR. KLINE: Within 30 days.

11 MS. PHILLIPS: Within 30 days or
12 the license will be suspended.

13 CHAIRPERSON MILLER: Okay. Mr.
14 Kline, does your client accept this Offer in
15 Compromise of \$350 to be paid within 30 days?
16 And if not paid within 30 days, the license
17 will be suspended.

18 MR. KLINE: Yes, it's acceptable
19 and the licensee understands that if it's
20 accepted, that they waive their right to a
21 hearing and waive their right to appeal.

22 CHAIRPERSON MILLER: Okay. Good.

1 Any questions by Board Members? All right.
2 Then I would move approval of this Offer in
3 Compromise of \$350 to be paid today or paid
4 within 30 days..

5 MEMBER SILVERSTEIN: Second.

6 CHAIRPERSON MILLER: And if it's
7 not paid within 30 days, the license will be
8 suspended until payment. Okay. It has been
9 seconded by Mr. Silverstein.

10 All those in favor say aye.

11 ALL: Aye.

12 CHAIRPERSON MILLER: All those
13 opposed? All those abstaining? The motion
14 passes 6-0-0.

15 MR. KLINE: Thank you.

16 CHAIRPERSON MILLER: Okay. Thank
17 you.
