CHAIRPERSON MILLER: So now, we can go to Sonya's Market. Okay. Case No. 14-CMP-00270, Sonya's Market located at 2833 11th Street, N.W., License No. 85579, in ANC-1B. Good morning.

MR. PARK: Good morning. My name is Sang Park, Sonya's Market.

CHAIRPERSON MILLER: Your name is Sang Park?

MR. PARK: Yes, ma'am.

CHAIRPERSON MILLER: And are you the owner?

MR. PARK: Yes, ma'am.

CHAIRPERSON MILLER: Okay. And with you?

MS. PARK: My name is Jung Park. I'm his wife.

CHAIRPERSON MILLER: Okay. Good. And for the District?

MR. STERN: Michael Stern

1 representing the District of Columbia.

2 CHAIRPERSON MILLER: Okay. Mr.  
3 Park, did you receive notice of this hearing?

4 MS. PARK: Yes.

5 CHAIRPERSON MILLER: Did you read  
6 it and understand it?

7 MS. PARK: Not all of it, but --

8 CHAIRPERSON MILLER: You both read  
9 it and understood it?

10 MS. PARK: Yes.

11 CHAIRPERSON MILLER: Okay. Good.  
12 So we don't have a notice issue in this case.  
13 You got notice?

14 MS. PARK: Yes, ma'am.

15 CHAIRPERSON MILLER: Okay. So,  
16 Mr. Stern, do we have any preliminary matters?

17 MR. STERN: Yes. My understanding  
18 is the parties have agreed to an Offer in  
19 Compromise, which we hope the Board will  
20 accept, totalling \$350 to be paid within 30  
21 days to resolve this matter.

22 CHAIRPERSON MILLER: So, Mr.

1 Stern, just to be clear, does --

2 MR. STERN: Oh, and if not paid  
3 within 30 days, the license will be suspended  
4 until it is paid.

5 CHAIRPERSON MILLER: Okay. All  
6 right. Good. Thank you.

7 MR. STERN: Yes.

8 CHAIRPERSON MILLER: All right.  
9 So let me ask Mr. Park. Do you agree to this  
10 Offer in Compromise of a \$350 fine to be paid  
11 within 30 days? If it's not paid within 30  
12 days, your license will be suspended until it  
13 is paid. Okay. Do you agree to that?

14 MR. PARK: Yes.

15 CHAIRPERSON MILLER: Do you  
16 understand you waive your right to a hearing  
17 and appeal, also?

18 MS. PARK: (No audible answer.)

19 CHAIRPERSON MILLER: That means  
20 you are accepting this voluntarily, so you  
21 wouldn't be appealing to the courts. You need  
22 to say it, so it's on the transcript. Do you

1 agree to that?

2 MS. PARK: Agree.

3 CHAIRPERSON MILLER: Okay.

4 MS. PARK: Can we pay today?

5 CHAIRPERSON MILLER: Can I repeat

6 the question? Can I repeat what?

7 MR. STERN: I think the question

8 was, can he pay today.

9 CHAIRPERSON MILLER: Can you pay  
10 today?

11 MR. STERN: Any time within 30  
12 days.

13 CHAIRPERSON MILLER: Absolutely.

14 MEMBER SILVERSTEIN: Yes.

15 MR. STERN: Yes.

16 MR. PARK: Thank you.

17 CHAIRPERSON MILLER: No, no, you  
18 are not excused yet. We have to -- we will  
19 let you know. We have to approve this. Okay.

20 So all right, I'm going to move  
21 that we approve this Offer in Compromise of a  
22 fine of \$350 to be paid within 30 days or else

1 the license will be suspended pending payment.

2 MEMBER SILVERSTEIN: Second.

3 CHAIRPERSON MILLER: Mr.

4 Silverstein has seconded the motion.

5 All those in favor say aye.

6 ALL: Aye.

7 CHAIRPERSON MILLER: All those  
8 opposed? All those abstaining? The motion  
9 passes 6-0-0. Okay. Wait for this.

10 MR. PARK: Thank you.

11 MS. PARK: Thank you.

12 CHAIRPERSON MILLER: Okay. Thank  
13 you. Here, no wait. Get your piece of paper.
