ORDER ON VOLUNTARY AGREEMENT







Cooperative (Voluntary) Agreement

AGREEMENT

Made this 30th October day of ~~September~~ 2006, by and between Harris Teeter, Inc., ("Applicant") and Advisory Neighborhood Commission 6B ("ANC") (collectively, the "Parties").

WITNESSETH

WHEREAS, Applicant's application for a Retailers Class "B" Full Service Grocery Store license for premises, 1391 Pennsylvania Avenue, S.E. Washington, D.C. 20003 (the "Premises"), ABC Liquor License # 75692 is now pending before the District of Columbia Alcoholic Beverage Control Board (ABC); and

WHEREAS, the Premises is within the boundaries of the ANC; and

WHEREAS, the parties desire to enter into an agreement governing certain understandings regarding the issuance of a Retailers' Class "B" Liquor License at the subject premises;

NOW, THEREFORE, the Parties agree as follows:

1. The licensee will not break up manufacturer's retail package of the product, and will not sell singles larger than 24 oz.

The Parties further agree that any failure of the Applicant to comply with the terms of this Agreement will constitute grounds for the ANC to petition the ABC Board for issuance of an order to show cause pursuant to 23 D.C.M.R. 1513.5.
