**ORDER CANCELLING LICENSE**


The Alcoholic Beverage Regulation Administration (ABRA) has reviewed its records and determined that Derron C. Smith, t/a 1820 Bar & Lounge, located at 1820 Benning Road, N.E., Washington, D.C., has failed to pay the second year license fees for License No. ABRA-086024, a Retailer's Class CT License. Specifically, you failed to pay the license fees for the period of 2011 to 2012, for your license by September 30, 2011, the deadline for all Retailer's CT licenses, despite being notified of the payment date.


