THIS AGREEMENT, ENTERED INTO BY AND BETWEEN SOLAR ECLIPSE, INC/ECLIPSE AND MR. JOHNIE HOLLIS, ET. AL ASSOCIATION BECOMES EFFECTIVE UPON ITS SIGNING BY THE INDICATTED PARTIES, AND REMAINS IN EFFECT UNTIL FURTHER NOTICE.

THE PURPOSE OF THE AGREEMENT IS TO ENSURE THAT SOLAR ECLIPSE, INC./ECLIPSE (hereinafter "ECLIPSE") CONTINUES TO EXHAUST EVERY EFFORT TO ENSURE THAT THE PEACE, ORDER AND QUIET OF THE NEIGHBORHOOD IS MINIMALLY IMPACTED BY THE PATRONAGE OF ITS MEMBERS AND GUESTS DURING ITS HOURS OF OPERATION.

ECLIPSE AGREES TO TAKE THE FOLLOWING ACTIONS TOWARD CONTINUED EFFORTS TO DIMINISH THE IMPACT OF PARKING IN THE COMMUNITY:

SHOULD ECLIPSE FAIL TO COMPLY WITH THE CONDITIONS OF THIS AGREEMENT, THEY UNDERSTAND THAT THE SOUTH CENTRAL CIVIC ASSOCIATION WILL REQUEST THE ALCOHOLIC BEVERAGE CONTROL BOARD TO INITIATE A SHOW CAUSE PROCEEDING FOR BREECH OF ANY PROVISIONS.

The purpose of the AGREEMENT is to ensure that SOUTH CENTRAL COMMUNITY ASSOCIATION and SOLAR ECLIPSE, INC. continues to exhaus every effort to ensure that the peace, order and quite of the neighborhood is minimally impacted by the patronage of SOLAR ECLIPSE members and guests during the hours that ECLIPSE, located at 2820 Bladensburg Rd., NE, is open for operation.

SOLAR ECLIPSE agrees to take the following actions toward continued efforts to achieve the spirit of this AGREEMENT.

A. PARKING

- 1. Stripe the seventeen parking spaces in the rear of the building.
- 2. Encourage patrons to utilize the seventeen parking spaces in the rear of the building.
- 3. Encourage patrons to abide by the parking regulations on Yost Place, 30th Street, Central Avenue, Bladensburg Road, and Franklin Street, NE.

B. SIGNAGE & LIGHTING

- 1. Place large sign at entrance and exit of **ECLIPSE**, reminding patrons to keep noise level to minimum upon exiting.
- 2. Install two (2) parking signs in rear of ECLIPSE, one on the building under the flood light and the second at the entrance of the parking light, each to read "Eclipse Parking".
- 3. Maintain increased lighting in rear parking lot of ECLIPSE.

C. ANNOUNCEMENTS AND NOTICES

- 1. **SOLAR ECLIPSE** will provide flyers/notice for events occurring prior to 9:00 pm on Saturdays and events occurring prior to 6:00pm on Sundays.
- 2. The notices referenced in No. 1 will be provided to the President of the South Central Civic Association (currently Mr. Thomas Randolph, 3017 Yost Place, NE) at least one week in advance of the scheduled event, or as soon as **SOLAR ECLIPSE** becomes aware should the one week notice not be possible.

D. TRASH

SOLAR ECLIPSE agrees to clean up areas surrounding ECLIPSE on Bladensburg Road, Central Avenue, Franklin Street, Yost Place and 30th Street, NE. on a regular basis.

The conditions of this **AGREEMENT** shall become a permanent part of the license application. It shall be monitored on a regular basis by the SOUTH CENTRAL COMMUNITY ASSOCIATION. Should major infractions be observed, SOLAR ECLIPSE will be given written notice, with a time frame of fourteen (14) days from date of receipt of said notice to cause corrective actions. Major infractions are listed as overcrowded, overflow, misuse of area, sanitation and clean-up, increased noise level, and failure to keep members and guest informed. Should SOLAR ECLIPSE fail to comply with the conditions of this AGREEMENT, they understand that the SOUTH **CENTRAL COMMUNITY ASSOCIATION** will request the ABC Board to initiate a show cause proceeding for breach thereof.

This AGREEMENT, entered into by and between SOLAR ECLIPSE, INC./ECLIPSE (hereinafter "ECLIPSE") and SOUTH CENTRAL CIVIC ASSOCIATION becomes effective upon its signing by the indicated parties.

The purpose of the Agreement is to ensure that ECLIPSE continues to exhaust every effort to ensure that the peace, order and quiet of the neighborhood is minimally impacted by the patronage of its members and quests during its hours of operation.

The D. C. Department of Public Works has installed "No Parking" signs on the 3000 block of the north side of Yost Place, N.E., in an effort to ensure access for emergency vehicles and to decrease the number of cars parking on this street during the hours that ECLIPSE is open for business. The Management of ECLIPSE, in cooperation with SOUTH CENTRAL CIVIC ASSOCIATION has initiated action to have residential parking designated in the community. However, it was determined that this matter would not be pursued at this time.

ECLIPSE agrees to take the following actions toward continued efforts to diminish the impact of parking in the community:

- 1. ECLIPSE will make every effort to fill the seventeen (17) parking spaces in the rear of the building during their hours of operation. Toward accomplishing this effort, ECLIPSE will (a) trim trees that are covering the two spot lights on each side of the rear of the building; (b) increase lighting by installing an additional flood light in the center of the building at the rear; (c) number parking spaces and require staff to park in the rear and assign spaces to regular attending members to encourage them to park in the rear; (d) and install two (2) signs in the rear (one will be on the building under the flood light, the other will be at the entrance to the parking lot) to read "ECLIPSE PARKING". These tasks will be completed by September 10, 1994.
- 2. ECLIPSE will place a large sign at the entrance encouraging its members and guests to refrain from parking on Yost Place, 30th Street, and Central Avenue. The sign will also request that loud noises be kept to a minimum when returning to their vehicles upon departure, and advise that there is parking in the rear of the building.
- 3. ECLIPSE will prepare a flyer that will be a part of their regular mailing to members. The flyer will remind members to refrain from parking on Yost Place, 30th Street and Central Avenue when patronizing the club, and advise that there is parking in the rear of the building.

- 4. ECLIPSE will require its Disc Jockeys to regularly make announcements reminding members and guests to keep noises to a minimum upon departure from the club.
- 5. BCLIPSE will regularly distribute flyers to members and guests upon their arrival, and place on the invitations that members have made for their special functions, the request that they refrain from parking on Yost Place, 30th Street and Central Avenue, advise that there is parking in the rear of the building, and request that noises be kept to a minimum upon departure from the club.

The conditions of this AGREEMENT shall be monitored on a regular basis by SOUTH CENTRAL CIVIC ASSOCIATION. Should violations be observed, ECLIPSE will be given written notice of same, with a timeframe of thirty days from the date of receipt of said notice to cause corrective actions. Should ECLIPSE fail to comply with the conditions of this AGREEMENT, they understand that SOUTH CENTRAL CIVIC ASSOCIATION will reinstitute its protest against their continued operations within the community.
