The Substantial Change Application filed by NHV Corporation t/a Haydee's 2000, to its Retailer's Class "CR" license, having been protested, came before the Alcoholic Beverage Control Board (Board) for a Roll Call hearing on March 26, 2008, in accordance with D.C. Official Code § 25-601 (2001). Douglass Sloan, Frederick Grant, Faith Wheeler, Malik Mendenhall-Johnson, Sara Green (A Group of Five or More Individuals), and Marian C. Bennett, Tracy Ellis, Chad Holmes, Jose Larious, Edward H. Smith II, Stephen A. Whatley, Jourdinia S. Brown, (Group of Five or More Individuals), filed timely letters of opposition.

The official records of the Board reflect that the Applicant and members of Advisory Neighborhood Commission 4B have reached an Agreement dated March 7, 2008 which has been reduced to writing and has been properly executed and filed with the Board. The Protestants have agreed to withdraw their protest conditioned upon the

**VOLUNTARY AGREEMENT**  
between  
**the Owner/s of Haydee's Restaurant and**  
**Commissioners Frederick Grant and Faith Wheeler**

The owner/s of Haydee's Restaurant agree:

1. To comply with all Alcoholic Beverage Regulation Administration (ABRA) regulations which apply to a retailer's Class C restaurant license, except for the construction of the stage.
2. To abide by the approved present Hours of Operation for Entertainment, which are:  
8 p.m. to 1:30 a.m. Wednesday and Thursday  
8 p.m. to 2:30 a.m. Friday and Saturday  
8 p.m. to 1:30 a.m. on Sunday.
3. To install additional soundproofing and or take other measures to reduce sound penetrating to neighbors, in accordance with established D.C. laws and regulations.
4. That live entertainment will take place only indoors.
5. To have on duty at least 3 security guards during live entertainment.
