ORDER GRANTING ANC 6B'S REQUEST FOR REINSTATEMENT

The Application filed by Jungbyun, Incorporated, t/a 7th & L Street Market, for renewal of its Retailer's Class B License, having been protested, came before the Alcoholic Beverage Control Board (Board) for a Roll Call Hearing on November 28, 2011, in accordance with D.C. Official Code § 25-601 (2001).

On November 21, 2011, pursuant to Title 23 of the District of Columbia Municipal Regulations ("23 DCMR") § 1602 (2004), the Board denied ANC 6B's protest due to its failure to file a timely protest.

On November 28, 2011, Commissioner Carol Green appeared at the Roll Call Hearing on behalf of ANC 6B and the Board's Agent informed her about the dismissal. ANC 6B timely filed a request for reinstatement with the Board, indicating that ANC 6B received two notices from the Alcoholic Beverage Regulation Administration (ABRA)

with two different sets of dates for the Applicant's Application. Therefore, ANC 6B's failure to timely file a protest letter resulted from an ABRA error.






