2 MS. FLETCHER: Would the parties in the
3 matter of Alta Strada please come forward. The parties
4 in the matter of Alta Strada. This is Case Number
5 16-PRO-00069, Alta Strada-City Vista, LLC trading as
6 Alta Strada, 465 K Street NW, License Number
7 ABRA-100140. This is a Retailer CR license renewal.
8 The protest issues are adverse impact on peace, order,
9 and quiet.

10 My name is Laverne Fletcher. I'm conducting
11 the roll call hearing as The Board's agent pursuant to
12 D.C. Official Code 1601.2. Introductions beginning with
13 the applicant.

14 MR. WHELAN: Good morning. Steven Whelan
15 from the Veritas Law Firm, legal representative for the
16 applicant.

17 MR. UHR: Steve Uhr, director of operations
18 for Schlow Restaurant Group which oversees Alta
19 Strada-City Vista.

20 MS. FLETCHER: That's Y-O-R-K?

21 MR. UHR: Pardon?

22 MS. FLETCHER: Did you say York?
