
ORDER DENYING REINSTATEMENT

The Application filed by Victor Giron and Carmen Martinez, t/a Acuario (Applicant), to renew their Retailer's Class CR License came before the Alcoholic Beverage Regulation Administration (ABRA) for a Roll Call Hearing on June 1, 2010, in accordance with D.C. Official Code § 25-601 (2001).


On January 20, 2010, pursuant to Title 23 of the District of Columbia Municipal Regulations (23 DCMR) § 1603.3, the Board dismissed the Protest filed by a Group of Five or More Individuals represented by Tim Turner (Protestants) because the Protestants failed to appear at the Roll Call Hearing. On June 14, 2010, the Protestants timely filed a request for reinstatement with the Board, explaining many of the Protestants were out of the country and that Mr. Turner had an emergency meeting at work at the time of the Roll Call Hearing. Upon consideration of their request, the Board does not find good cause to reinstate the Protestants pursuant to 23 D.C.M.R. 1603.3.


