**ORDER VACATING CANCELLATION OF LICENSE AND
REINSTATING LICENSE**

Alabaje Francis, t/a All Tyme Catering, failed to pay the third year license fees for his Retailer's Class Caterer License. Specifically, it failed to pay the license fees for the period of 2012 to 2013 for his license by March 31, 2012, the deadline for all Retailer's Caterer licenses, despite being notified of the payment date.

On May 9, 2012, the Alcoholic Beverage Control Board (Board) issued Board Order No. 2012-103 ordering the Licensee to cease and desist selling, serving, and permitting the consumption of alcoholic beverages on its property. *See Board Order No. 2012-103.* An ABRA Investigator personally served the Licensee with the Order.

The Board then issued Board Order No. 2012-274, dated June 13, 2012, which cancelled the Licensee's license. *See Board Order No. 2012-274.* ABRA mailed the Order to the Licensee and no returned mail was received by ABRA. Nonetheless, on July 20, 2012, the Licensee paid the license fees for the period of 2012 to 2013 and the late fee.




